Provisional Selection List of candidates for admission to the MDS Courses-2025 in various Government Colleges/Institutions of UT of J&K/Ladakh after the conduct of the 1st round of online counselling.

Pursuant to Notification No. 069-BOPEE of 2025 dated 05-07-2025, the Board notified the 1st round of online counselling schedule for submission of online preferences/choices w.e.f. 07-07-2025 to 09-07-2025 for filling up of seats of MDS Courses-2025. The list of candidates provisionally allotted seats in Government Colleges/Institutions of UT of J&K/Ladakh, is hereby notified as per **Annexure-A** to this notification, which shall be available on the official website of the Board viz. www.jkbopee.gov.in only.

The Provisionally Selected candidates are advised to report to their respective allotted Colleges/Institutions for completion of admission formalities up to 14th of July 2025, till 04.00 P.M., along with the following documents in original:

- BDS degree certificate;
- II. Registration with the State/ UT Dental Council/ DCI;
- III. Internship Completion Certificate (up to 30-06-2025);
- IV. Domicile Certificate of UT of J&K or Ladakh, as the case may be;
- V. Valid Reserved Category Certificate, wherever applicable, in terms of SRO 294 of 2005 dated 21-10- 2005 read with SRO 518 dated 02-09-2019, S.O. 176 dated 15-03-2024, and S.O. 305 dated 21-05-2024 (The cut-off date for validity of the category certificates shall be the last date for registration fixed by the BOPEE, viz, 29-06-2025);
- VI. Difficult Area Certificate in pursuance of SRO 48 of 2018 dated 30-01-2018;
- VII. NEET-MDS Score Card 2025;
- VIII. *NOC from Government/Competent Authority for in-service candidates to pursue MDS Courses 2025;
- IX. (For candidates belonging to the UT of Ladakh), an undertaking in the form of a compulsory Service Board (available on BOPEE Website) that he/she shall serve in the UT of Ladakh for a prescribed period immediately after completing the MDS Degree;
- X. For candidates belonging to the UT of Ladakh, their ST certificate issued by the competent authority shall be treated as a Domicile Certificate;
- XI. Any other documents, as requested.

The eligibility conditions for admission to these courses shall be as mentioned in Notification No. 066-BOPEE of 2025 dated 26-06-2025/e-Information Brochure available on the J&K BOPEE website.

It is hereby implored upon the management of all the concerned Colleges/ Institutions to ensure the veracity of documents, particularly the Category Certificates, wherever the admission is to be granted in lieu of a Reserved Category.

To complete the admission process within the prescribed cut-off date (14.07.2025), the concerned Colleges/Institutions shall keep their admission counters open even on holidays/off days to facilitate the candidates to complete their admission process well in time. However, the candidates in their interest shall avoid waiting for the last day to complete admission formalities since delay has the potential to cause hardships to the candidates only.

The Heads of the concerned Colleges/Institutions are advised to furnish the shortfall, if any, to the Board only through the JK BOPEE admission portal on 14.07.2025 up to 05.00 p.m.

Note:

- The admission of the candidates is purely provisional and shall be cancelled in case any information furnished by any candidate proves to be false/fabricated, and action as warranted under the rules shall be initiated against such candidates.
- II. The allotment of seats (discipline/institution) in respect of reserved category candidates has been made under the provisions of S.O. 176 of 2024 dated 15-03-2024, read with S.O. 305 dated 21-05-2024 (From Roaster points 21-42 for J&K candidates).
- III. The Concerned Colleges/Institutions shall ensure that, in case a person with disability is selected in open merit or some reserved category, the college/ institution concerned shall refer such case(s) to the Medical College concerned for constitution of special Medical Board to assess such candidates and make recommendations based on which colleges shall take further necessary

action. In case any such candidate does not fulfil the benchmarks of disability, he/she shall not be admitted to the course/ college, and the matter shall be reported to the BOPEE.

- IV. All candidates to whom a seat has been allotted in a first round based on merit-cum-preferences will have to compulsorily join college and course so allotted, within the prescribed period i.e., 14-07-2025 by completing requisite formalities i.e., submission of original documents as mentioned in the PSL notification and by submission of such other documents/undertakings as may further be required by the college. If interested, the candidate may participate in the second round of counselling for upgradation after filling fresh preferences.
- V. If any candidate fails to join the allotted College/Institution within the stipulated time, i.e., **14-07-2025** as notified by the Board, his/her claim on the seat shall cease. Such a vacant seat will be allotted in the next round of counselling within the prescribed period.
- VI. If a candidate after getting admission into a College/Institution intends to resign from the College/Institution, he can do so by submitting a resignation letter in the College/Institution by or before the last date fixed for reporting/joining by the BOPEE, i.e. 14-07-2025 otherwise the candidate will not be eligible for the 2nd round of counselling.
- VII. For the fee/documents required in the College/Institution, the provisionally selected candidates are advised to contact the concerned College / Institution before the last date of admission.
- VIII. The principals of the concerned Colleges / Institutions are advised to download a copy of this PSL Notification from the website of the Board, viz. www.jkbopee.gov.in, for reference and record.
- IX. The Nodal officers of the institutions/colleges must verify the documents mandatory for admission before allowing the candidate to join.
- X. The other terms and conditions shall remain the same as notified in the e-Information Brochure/Notifications & Notices issued by the Board in this regard from time to time.
