It is hereby informed to all eligible candidates desirous of seeking admission in **MDS courses** in all Government/ Private Dental Institutes including those under Private University- SGT University, Budhera, Gurugram in the State of Haryana for the Academic Session 2025-26, that the tentative schedule for Round-2 counseling is as under:

### **Note:**

- Fresh candidates can register for Round-2 of counseling if not registered in Round-1.
- The candidates, who have already registered themselves for the Round-1 and wish to participate in the Round-2, shall not be required to register again.
- Candidates, who have been allotted/joined seats in the Round-1 of counseling shall have to give their willingness/option to upgrade themselves in the Round-2 of counseling online otherwise they shall not be considered eligible for the Round-2 of counseling.
- The Candidates, who have joined on the allotted seat in the Round-1 shall have a right to retain already allotted seat and this shall be changed only if, he/she gets an upgraded opted seat during Round-2. However, **the candidates who wish to participate in the Round-2 of online counseling will have to submit their preferences/choices afresh. Candidates, who have joined, seat in Round-1 should give the fresh choices in order of preferences for the seats in which they wish to upgrade themselves.**
- All candidates (already registered (irrespective of their admission status) and freshly registered candidates) who wish to participate in the Round-2 of counseling and want to opt for State Quota Seats in only **Government/Private Dental**

**Colleges** shall be required to deposit online an amount of Rs. 25,000/- (Rs. 12500/- for SC/SCD/BCA/BCB/ PWBD of Haryana State) and if the candidate wishes to also opt for **State Quota Seats/Management Quota Seats in Private Dental Colleges including Private Universities** then he/she shall have to deposit online an amount of Rs. 2.00 Lakh. This facility shall be available in the login ID of the candidates on admission web portal.

**In case of failure of any registered candidate (whether freshly registered or the candidates who have joined seats in the Round-1 and want to upgrade their seat in the Round 2) to deposit the requisite security amount, they will NOT be considered eligible to participate in the Round-2 of counseling.**

- In case of candidate joins on the allotted seat, this security amount shall be adjusted in the tuition fee of the first year of PG Course.
- If the candidates are allotted any seat as per their preference, but they do not join on the allotted seat, the security amount shall be forfeited. However, these candidates will be eligible to participate in the Round -3 after forfeiture of previous security amount and deposition of fresh security amount.
- The security amount of the candidates who are not allotted any seat during the Round 2/Round-3 shall be returned after the completion of the counseling process.
- The candidates who join on the allotted seats in the Round-2 of counseling, will be eligible to participate for Round-3 of counseling.
- Any candidate who had joined in Round-1 but did not participate in Round-2 counseling or did not resign from the Round1 joined seats, will also be allowed to participate in Round-3 after deposition of security amount.
- The candidates who join the seat allotted to them during the All India Quota/Any State Quota upto Round-3 of counseling shall not be eligible in further / stray round of counseling. The candidates will have to give an undertaking about the same.
- If a candidate freshly registered in Round-2 is not allotted a seat, he/she can participate in Round-3 without deposition of Security Amount.
- However, if an upgraded candidate does not want Round-1 seat, he/she may exit with forfeiture of security amount.
- In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the allotted seat shall be cancelled and the security amount fee shall be forfeited.

**Note: -**

- i. The choices filled by the candidates for the Round-1 of counseling shall be treated as null and void and the candidates will have to fill fresh choices.
- ii. The above instructions should be read in accordance with NEET MDS information bulletin 2025 and Govt. Notification No.16/08/2024-6HB-IV dated 10.07.2025 and public notices issued time to time.
- iii. Haryana Government Notification No. 40/13/2024-1SW dated 16.07.2024 is applicable for BC-A/BC-B category candidates.

2. Certificates having passed BDS examinations from Institutions recognized by DCI.
3. Three copies of the recent photographs (passport size) self attested used for NEET MDS 2025 form.
4. Internship completion certificate certifying the date on which the candidate has completed one year rotatory internship. The date of completion of internship training as notified by MoHFW/DCI/MCC i.e. **upto 30.06.2025**.
5. Foreign Dental Graduate Exam result (if applicable).
6. Character certificate of the Head of Institution last attended/First Class Executive Magistrate.
7. Bonafide resident certificate issued by competent authority of the State Government of Haryana (if applicable/bonafide resident certificate issued by the competent authority of the State Government(if applicable).
8. Certificate of registration with any State Dental Council/ DCI at the time of counseling.
9. Caste Certificate issued by competent authority of the Haryana State Government (if applicable).
10. Certificate of Dependent of Freedom Fighter Certificate issued by competent authority of the Haryana State Government (if applicable).
11. Certificate of ESM issued by competent authority of the Haryana State Government (if applicable).
12. Creamy /Non-creamy certificate for BC-A/BC-B category candidates as per Govt of Haryana notification dated 16.07.2024. certificate for the year 2025-26 & issued on and after 01.04.2025 should be brought at the time of Physical document verification.
13. Certificate of Disability issued by notified centers by NBE/MCC or Medical Board PGIMS, Rohtak (if applicable).
14. Result card of NEET-MDS-2025.
15. HCDS category candidates must produce valid NOC issued by the competent authority failing which the In-service candidates will not be eligible for counseling.
16. Aadhar card/PAN card/Driving license/Passport/Voter ID/Ration Card/ParivarPehchan Patra.
17. Printout of Application form.

This is information all candidates seeking admission to **MDS Courses (Round-II)** in all Government/ Private Unaided Dental Institutes including those under Private University - SGT University, Budhera, Gurugram in the State of Haryana for the Academic Session 2025-26 **under NRI quota seats** are advised to go through the Govt. of Haryana Notification No. 16/08/2024-6HB-IV dated 10.07.2025 carefully regarding eligibility criteria and other details. The following documents are required for NRI/OCI/PIO Category Candidates

1. Copy of the Passport of Candidate/Parents/Sponsorer as the case may be.
2. Documentary evidence/ certificate of NRI/OCI/PIO/ as per Govt. of India instructions issued from time to time (As applicable).
3. Sponsorship affidavit from NRI stating that Sponsorer will bear all the expenses for the whole duration of study of the candidate (if applicable).
4. Relationship affidavit (Relation of candidate with Sponsorer with family tree and supportive documentary evidence in form of Passport/PAN Card / Aadhar Card/ Ration Card 10<sup>th</sup> - 12<sup>th</sup> certificate etc).
5. Provisional tuition fee has to be paid only through the NRE/NRI/NRO/Foreign bank account of Candidate/Parent/Sponsorer(as the case may be) through admission Web Portal only. Amount can also be paid in equivalent INR.
6. Proof of NRE/NRI/NRO/ Foreign Account.
7. Candidates who are provisionally allotted seats have to deposit "provisional tuition fee" through admission web portal only. After successful document verification by admission committee, the candidate will be issued provisional admission letter on web portal and the candidate have to submit joining report in the concerned college as per schedule.
8. Candidates applying under NRI category as per Govt. Notification No.16/08/2024-6HB-IV dated 10.07.2025 should ensure that they strictly fall under the categories as mentioned in the Notification and have documentary evidence to support their claim

Please note that, due to non-availability of any of above mentioned documents at the time of document verification, the candidature of NRI candidate will not be considered **AND THE PROVISIONALLY ALLOTTED SEAT TO THE CANDIDATE WILL BE CANCELLED.**
