Important information regarding Submission of Online Application Form for Preparation of Merit List based on the basis of NEET (UG)-2025 result and conduct of 1st,2nd,3rd & Stray Vacancy round of online counselling for admission to M.B.B.S. course in Laxmi Chandravansi Medical College & Hospital, Bishrampur,Palamu

Health, Medical Education and Family Welfare Department, Ranchi has earmarked 75 M.B.B.S. course seats for Laxmi Chandravansi Medical College & Hospital, Bishrampur, Palamu. Out of allocated 75 seats, 60 seats will be under Unreserved Category for NEET(UG)-2025 qualified candidates who are resident of any region of Indian Republic including local resident of Jharkhand state and rest 15 Seats will be under NRI Quota.

The Candidates claiming for admission under the NRI Quota seats, will have to fill in a separate format and produce concerned original certificates/documents at the time of admission.

In pursuance of the above, online application forms are invited by the Board from such eligible candidates who fulfill the following eligibility criteria:-

- a. <u>Age Criteria</u>:-The candidate has completed 17 years of age at the time of admission or will complete that age on or before 31 December of the year of his/her admission to the first year of the Undergraduate Medical Courses i.e. 31.12.2025. There is no upper age limit.
- b. Educational Criteria:- The candidate must have passed in Physics, Chemistry, Biology/Biotechnology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology/Bio-technology at the qualifying examination as mentioned in the Regulations of NMC and DCI. In addition, they must have got a rank in the merit list of NEET (UG)-2025 for admission to Undergraduate Medical Courses. In respect of the candidates belonging to Scheduled Castes, Scheduled Tribes or Other Backward Classes (NCL), the minimum marks obtained in Physics, Chemistry and Biology/Biotechnology are taken together in the qualifying examination shall be 40% marks instead of 50% marks for Unreserved and General-EWS Candidates. In respect of PwBD/PwD candidates as per NMC and DCI Regulations, the minimum marks in the qualifying examination in Physics, Chemistry and Biology (or Botany & Zoology)/Biotechnology taken together shall be 40% instead of 50%.
