**State Dental P.G. Seats (MDS) Round 3 Allotments-2025**

In continuation to the earlier notifications, the registration for round 3 allotment process for PG Dental course (MDS) in Rajasthan shall commence on-line from 06.08.2025. The schedule for allotment will be as below:

**Schedule for Allotment Process - Round 3**

<b>Application form (Registration)</b> Start date for filling of on-line application form and deposition of required application fee  <b>It is a mandatory step for subsequent process of counseling and allotment.</b>  <b>Both the parts (Part 1 and Part 2) of the application form must be filled and completed.</b>  <b>Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same.</b>  <b>Those who are already registered/have applied, need not register/apply again.</b>	06.08.2025

Verification, Allotment and Reporting by Sr. Demonstrator candidates for In-Service Quota (sub quota), (before the Board, 9.00 am sharp at Academic Block, SMS Medical College, Jaipur) (after applying/registering as per the procedure) All such candidates must present themselves physically along with all original relevant documents, before the Board	10.08.2025, 9.00 am
Publishing of provisional seat matrix (after Sr. Demonstrator allotments)	10.08.2025
Deposition of security amount (refer the Instructions Booklet for details)  Rs. 25000/- for all candidates irrespective of their category, opting for MDS seat in Government Dental College or Private Dental College.  Candidates who have deposited the security amount in Round 1 or Round 2 but not allotted a seat, need not deposit in Round 3.  A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3 will be eligible only on fresh application and on depositing security amount again. His/her earlier deposited security amount will be forfeited.	11.08.2025 to 13.08.2025 (4.00 pm)
On-line choice filling locking of the choices by the candidates (including filling up and saving of the choices / changing the filled choices multiple times)  Note: Choice filled by candidate in Round 1 / Round 2 will not be considered for Round 3 allotment.  Following candidates are eligible for Round 3 and must fill choices to participate in Round 3: 1. Earlier registered candidates who did not get allotment in Round 1 / Round 2 2. Round 1 candidate allotted and joined but resigned after Round 2 without forfeiture of security amount 3. Joined candidates of Round 1 / Round 2 who wish to upgrade (with fresh registration and with security amount deposition) 4. Newly registered candidates	11.08.2025 to 13.08.2025 ( Up to 11:00 pm) (choices auto- locked at 11:00 pm on 13.08.2025)

Reporting, document submission (including prescribed eligibility criteria) at the allotted college desk at Academic Block, SMS Medical College, Jaipur along with printout of allotment letter, all original documents, deposition of prescribed one year tuition fee and completion of all other formalities (Refer to respective college website), required bonds etc. and other documents as listed in instruction booklet.  Note: 1. Round 2 joined candidates who get upgraded in round 3 shall bring fee receipt issued by Round 1 / Round 2 joined college and will complete all other formalities of allotted college (their original documents will be transferred directly to Round 3 upgraded college).	18.08.2025 to 20.08.2025 (10.00 am to 5.00 pm)

1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3 will be eligible only on fresh application and on depositing security amount again. His/her earlier deposited security amount will be forfeited.
3. **All PwD candidates** must present themselves physically for document verification before the admission board on 10.08.2025 as per the notification and the list to be made available at the website.
4. All concerned / fresh candidates are required to deposit non-refundable application fee of Rs. 4000/- (Rs. 3000/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
5. All such candidates having joined status up to Round 2 who retain their seat in Round 3, will have to complete all other formalities of their allotted college (Refer to respective College Website) at the time of joining for Round 3.
6. The candidates are advised to visit the websites regularly for registration and other relevant information.

**Important: For candidates willing to participate/upgrade in Round 3, it is mandatory to fill fresh choices in Round 3 (irrespective of whether the candidate was allotted/joined a seat in Round 1 / Round 2 or not).**

**The choices filled by candidate in Round 2 shall be scraped and will not be considered for Round 3. If a candidate does not fill fresh choices for Round 3, then he/she will not be considered for allotment/upgradation in Round 3.**
