#### Information regarding the second round of seat allotment for UGCET - UGNEET 2025

The second round of seat allotment for Medical, Dental, Homeopathy, Ayurveda, Unani, Naturopathy and Yoga, Engineering, Architecture, Farm (Agricultural) Sciences, Veterinary, B-Pharm, Pharm-D, B.Sc. (Nursing), BPT, BPO, Allied Health Sciences etc. courses will be conducted through online. The second round seat allotment schedule has been given separately.

#### **AYUSH Courses**

The seat matrix given by the Government for AYUSH courses has been published on the KEA Website. It will be considered for seat allotment in this second round. Candidates who have qualified in UGNEET 2025 and have already participated in the first round (excluding those who have selected CHOICE-1, paid the fee and got admission in the college) can enter the options for AYUSH courses in the order of priority if they are interested.

#### Procedure for allotment of seats in the second round

Before the commencement of the second round of seat allotment, the seat matrix will be published by including all the seats mentioned below and the second round of seat allotment will be done in the same manner as the first round of seat allotment as per the roster system.

Then, steps will be taken to allot the unfilled seats of Rural, Kannada Medium, Kalyana Karnataka, and various reserved category seats to the candidates of the respective reserved categories in the second round as per the rules. The seats that may remain after that will be considered for general eligibility as per the rules and candidates of all categories including reserved category will be considered in the same second round of seat allotment. Information in this regard has already been published. Allotment of seats for all the new seats for the second round including AYUSH courses will be done in the same manner as per the above rules.

#### Instructions for entering Options in the Second Round

- 1. The seats available for the second round of seat allotment will be announced on the KEA Website.
- 2. It is advised to check the KEA Website from time to time for the availability of seats as the seats which are cancelled/forfeited/newly added will be announced from time to time.
- 3. After the enabling of the Option Entry portal and after agreeing to the terms and conditions and giving consent, eligible candidates can carefully reorder their options in order of preference by logging into the portal and by confirming the fee details.

- 4. Seats that may become available due to reasons that may arise during seat allotment or seats that may be cancelled after the publication of the seat matrix or seats that may be newly added to the seat matrix will also be considered for allotment. Therefore, candidates are advised to retain all the options they are interested, irrespective of the seats shown in the seat matrix. (Only if the options are in the list of options, they will be able to get the seats they are interested in.)
- 5. In case it is decided that there are unwanted options in the options list, it can be removed in consultation with their parents.
- 6. Candidates can change or remove the higher order options. In the second round of seat allotment process, the seats arising due to candidates taking up other seats are also allotted on merit basis, so that the candidates can retain their seats even if there is no availability of seats in the seat matrix. Candidates are advised to mention all the seats they are interested in order of priority.
- 7. Candidates who wish to participate in the second round means will be participating in the second round to select a seat better than the seat allotted in the first round. If the candidates do not get any seat of higher order options in this round, then the same seat will remain which was allotted in the first round.

NOTE: Consequential vacancies that arise during the allotment after the candidate merit / turn cannot be claimed.

### Candidates who have opted for CHOICE-2 should follow the following instructions.

- CHOICE-2 candidates will participate in the second round by holding the seat selected in the first round with them. If any higher order seat is allotted to such candidates, the seat allotted in the first round will be cancelled. If no seat is allotted in the second round, the seat allotted in the first round will remain with them.
- ✓ High Order Options means, if a candidate has entered 180 options, out of which, if the candidate
  has been allotted seat of option number 123 in the first round, then the options from 1 to 122
  will become High Order Options. If a seat is allotted on merit basis for any of the Higher Order
  Options in the second round, the seat allotted in the first round will be cancelled.
- ✓ If no seat is allotted in Higher Order options, the seat selected in the first round will be in the name of the candidate.
- ✓ Candidates can change the High Order Options or modify the priority or remove any option if they are not required.
- ✓ For CHOICE 2 candidates the seat allotted in the First Round will be considered as last option. The CHOICE 2 candidates should be very careful while submitting the options. One should understand that the seat allotted in the First Round will become the last option, it means all the higher options saved by the candidates will be treated as options for seat allotment.

- ✓ If any candidate is intending to retain the same seat which is allotted in the First Round, then he / she has to delete all such options in consultation with their parents, then the seat allotted in the First Round will be retained.
- ✓ Eligible candidates can enter their options for Ayurveda, Unani seats if they are interested.

#### Candidates who have opted for CHOICE-3 should follow the instructions given below.

- After the commencement of second round option entry and after the CHOICE-3 candidates log in and
  give their consent, all the options entered by the candidates in the first round will be shown (except
  the seat allotted in the first round), candidates can change the options or modify the priority number
  or remove any options if they are not required.
- Eligible candidates can enter the options if they are interested in Ayurveda, Unani seats.

#### The following types of seats are made available for second round seat allotment.

- a. Unfilled seats of First Round
- b. Newly added seats after first round, if any.
- c. Seats of CHOICE 3 or CHOICE 4 selected by the candidates allotted in first round.
- d. Cancelled / Surrendered seats after first round.
- e. Seats of candidates not exercised any CHOICEs for the seat allotted in first round.
- f. Exercised CHOICE 1 in First Round but failed to make payment.
- g. Exercised CHOICE 2 in First Round but failed to make payment (Medical / Dental / Homeopathy)

#### Seats available in the second round of seat allotment process

- 1. Seats arising during allotment.
- The candidates who have selected CHOICE-2 for the seat allotted in the first round and if any higher order seat gets allotted in the second round, the seats of the first round will be considered for allotment.

#### The following categories of candidates can participate in the second round

Details of candidates eligible to participate	Methods to be followed
Those who have not been allotted any seat in the first round	Once the candidate gives consent by logging in the portal during the second round, then only the options entered by the candidates will be shown in the option entry portal. Candidates can change the options or modify the priority numbers or remove the options if they are not required.

Those who have selected CHOICE-2 in the first round.	Higher order options will only be shown in the portal. Candidates can change or modify the options / prioritise numbers or remove the options if they are not required.
Those who have selected CHOICE-3 in the first round,	After starting the process of entry of options in the second round, must log in to the option entry portal and give their consent. After this, all the options entered by the candidates in the first round will be shown to the CHOICE-3 candidates (except the seat allotted in the first round).

# Information regarding the announcement of mock or provisional results of seat allocation and subsequent announcement of final results

The seats remaining / cancelled / newly added after the first round of seat allotment will be considered for the second round of seat allotment. First, the mock or provisional result of the second round of seat allotment will be published on the KEA Website. Please note the following:

- 1. Karnataka Examination Authority will announce the mock or provisional result of the second round and wait for the announcement of the 2nd round result by MCC.
- 2. After the 2nd round result of the MCC, if you wish to vacate the seat allotted by KEA, you will be allowed to do so.
- 3. Candidates who have got a medical/dental seat from MCC or in other states and wish to vacate the KEA seat can do so without any penalty.
- 4. No seat will be cancelled without penalty for other candidates. (penalty will be applicable)

#### **Second Round Final Seat Allotment Result**

5. For the convenience of the candidates, all the seats (if any) cancelled in KEA will be considered and the second round of seat allotment will be re-run with the same priority of options of the eligible candidates had entered for the second round and the second round final seat allotment result will be published. There is a possibility of higher order seat allotment. Again, there will be no possibility of changing the options for the second round.

#### Instructions for selecting CHOICEs after the second round final seat allotment result

 For courses like Engineering, Architecture, Agricultural Science, Veterinary, B-Pharm, Pharma-D, B.Sc (Nursing), BPT, BPO, Allied Health Sciences, Naturopathy and Yoga, only CHOICE-1 or CHOICE-4 will be allowed to be selected after the second round of seat allotment.

#### Instructions for making CHOICEs after the second round of final seat allotment results

#### **Medical and Dental and AYUSH courses**

- 1. Candidates will not be allowed to make any CHOICEs after the declaration of the second round of seat allotment results.
- 2. Candidates must get admission for the allotted seat, hence candidates and parents should enter only the college's option they want to join, as the seat allotment is done on the basis of merit and considering the options submitted by the candidates, the allotted seat cannot be denied. Therefore, candidates should carefully submit the options in the order of priority.
- 3. Failure to pay the fees or take admission in the college after the second round of seat allotment will result in legal action against such candidate.
- 4. Candidates who are not allotted a medical seat can participate in the medical mop-up round as per the instructions/schedule.
- 5. Those who have been allotted Dental seats can participate in the Medical mop-up round as per the instructions/schedule but will not be allowed to participate again in the Dental seats mop-up round.
- 6. Those who have been allotted AYUSH seats can participate in the Medical mop-up round as per the instructions/schedule but will not be allowed to participate again in the AYUSH seats mop-up round.
