UGCET- 2025 – SECOND ROUND – Final Results

In view of the All India Second round schedule for UGNEET is being under revision, and it is getting delayed for few more days and to benefit the UGCET candidates it has been decided to provide four CHOICEs to the candidates who have been allotted seats in second round of UGCET -2025.

Candidates who are allotted seats in the second round will be given four different CHOICEs. Before choosing any CHOICE out of the four CHOICEs, the candidates are advised to read the description of each CHOICE, understand it properly, discuss it with their parents and select the CHOICE they feel is suitable for them. Candidates who do not choose any CHOICE out of the four CHOICES will not be eligible to participate in the next rounds.

- If they select Choice-1, then they will not be permitted to participate in the 3rd round of Engineering, Architecture, Farm Science, Veterinary, Yoga & Naturopathy, B.Sc. (Nursing), B-Pharma, Pharma-D etc seat allotment and Medical / Dental / AYUSH courses allotment as well.
- In case if the candidate takes decision that he / she is not interested for any change or up-gradation for higher priority option seat but willing to take admission for the seat allotted in second round, then only they have to choose Choice-1.
- Candidates opting for CHOICE-2 will have to pay the prescribed fee to be eligible to participate in the 3rd round if a seat is allotted in any discipline or category in the second round.
- Candidates opting for CHOICE-3 will not be required to pay the fee for the seat allotted in the second round. However, they will have to pay a minimum fee of Rs. 10,000/- to participate in the 3rd round.

NOTE: There will be NO CHOICEs to exercise to the candidates after the publication of 3rd round seat allotment results. Candidates who have allotted seat in the 3rd round in any discipline are required to pay the prescribed fees (if not paid) and should compulsorily report to the allotted college, because the seats will be allotted based on rank / merit and the priority of options entered by the candidates. If any candidate fails to report to the college after allotment of seats in the Second Round, legal action will be initiated against such candidate in accordance with law and such candidates will not be allowed for further three years for the same course / discipline. If candidate decides that unwanted options are there in their option entry portal, he / she can delete it in consultation with their parents.

UGCET-2025 – SECOND ROUND CHOICES

CHOICE-1: I am 100% satisfied with the seat allotted in the second round and will join the college, I do not need any change. I also do not want to participate in the next rounds (for courses like UGNEET-Medical or Dental or AYUSH or UGCET-Engineering / Architecture / Farm Science / Veterinary / Pharmacy / B.Sc Nursing, Naturopathy and Yoga, BPT, BPO, Allied Health Science etc.), hence I should not be considered for seat allotment in any of the next rounds. I confirm that I will pay the fee for the seat allotted in the second round, download the Confirmation Slip and then get the OTP through the college portal login by Online Face Recognition, verify the eligibility, download the admit card and get admission within the stipulated date.

Action: If the candidates are going to take the above steps, they can select CHOICE-1 from the specified link on the KEA Website and take the next step.

Any Choice-1 selected candidate fails to pay the fees or paid the fees but failed to download the Confirmation Slip or fails to report to the College, he / she has no claim further on such allotment, revert back to the seat matrix, and he / she will not be considered for allotment of seats in the subsequent round, fee paid if any will be forfeited.

Implication: Not eligible to participate in the subsequent rounds.

Important: Before opting this choice candidate is advised to make sure that he / she cannot come back to Option Entry Process in UGCET-2025 / UGNEET-2025

The candidates who exercise CHOICE-1 Should follow the guidelines detailed below:

- a. If satisfied, exercise CHOICE-1 on the KEA Web-portal.
- b. Download / print the Challan from the KEA website.
- c. In the Challan, the details of the candidate will be pre-printed, such as Name, CET Number, College / Course Allotted details, Fee to be paid, Bank Account Number. Candidate has to confirm the printed details and affix the signature on the Challan.
- d. Pay the prescribed fee.
- e. Download the Confirmation Slip, report to college with all the necessary original documents (with two sets of photocopies) to take admission.
- f. After verifying all the original documents, the college will get the details of the candidate in their official login (College Portal), verify the photo (Online Face Recognition) and then send an OTP to the candidate's mobile number via WhatsApp.
- g. After OTP verification, the college will download the admission letter from their portal. (Candidates will not be allowed to download the admission letter)
- h. Report to the college along with the Original Documents on or before the last date mentioned in the Admission Order.
- 1. Then the candidate has to sign in the Admission Order, collect the candidate copy of the admission order and submit the original documents.
- j. After these steps, the candidate's admission process is complete and he/she will not be eligible to participate in any further rounds.

Steps to be followed by CHOICE-1 Candidates - Rules

First step

- Fee payment

Admission will be considered final only after all the above steps are followed.

Choice 2: I am Satisfied with the UGCET-2025 allotted seat but wish to participate in the next round. I will pay the prescribed fees by downloading the Challan / allotted details from the KEA website for the seat confirmed or allotted in the second round. If higher options are allotted in the 3rd round, then seat allotted in the second round gets cancelled automatically OR if higher order options seats are not allotted in the 3rd round, then the seat allotted in the second round shall remain in candidates favour.

Implication: Eligible to participate in the 3rd round keeping the seat allotted on hold. However, if a seat in the higher order options gets allotted the candidate loses his old seat. There is no choice between the earlier allotted and newly allotted seats.

Additional Instructions to Choice-2 candidates of second round

- The candidates who exercise Choice-2 should compulsorily pay the fees for the allotted seat in the second round.
- Candidates who exercise Choice-2 are participating in the 3rd round by holding the seat allotted
 to them in the second round. If higher order options are allotted to them in the 3rd round, the
 seat allotted during second round will automatically stand cancelled. OR if any of the Higher
 Order Options are not allotted in the 3rd round, then the seat allotted to them in the second
 round will remain with the candidate.
- Higher order options means, presume that the candidate has entered 85 options, and the seat is
 allotted for his / her priority number 67 in the second round, then the priority number 1 to 66
 are the higher order options. The lowered options i.e., from 68 to 85 get deleted automatically.
- If any of the Higher Order Options are not allotted, then the seat allotted to them in the second round will remain with the candidate.
- Candidates can alter / delete / rearrange / modify the higher order options.
- Candidates are advised to enter only such options, if the seat is allotted, they have to
 compulsorily join the selected college in the 3rd / Casual Vacancy Round seat allotment
 without giving any reasons /excuses because the seats will be allotted based on rank / merit and
 the priority of options entered by the candidates.
- If candidate decides that unwanted options are there in their option entry portal, he / she can delete it in consultation with their parents.

Choice 3: I am not satisfied with allotted seat but wish to participate in the next round with all the already entered options except the allotted options by surrendering the allotted seat and also re-ordering of already entered options. I will pay the Caution Deposit of Rs.10,000/-.

Implication: Eligible to participate in the subsequent round by rejecting the allotted seat.

Action: Candidates are advised to retain only such options, if the seat is allotted in the 3rd round, then they have to compulsorily join the selected college in the 3rd / Casual Vacancy Round seat allotment without giving any reasons /excuses because the seats will be allotted based on rank / merit and the priority of options entered by the candidates.

IMPORTANT:

(a) Candidates who have opted for CHOICE-3 will not be required to pay the fee for the seat allotted in the second round. However, they will have to pay Caution Deposit of Rs. 10,000/- to participate in the third round.

(b) Candidates who have opted for CHOICE-3 will forfeit the seat allotted in the second round (without retaining it) and participate in the third round. Such candidates will have to opt for

the seat only if the seat is allotted to them on the basis of merit in the third round.

(c) After the process of commencement of options entry in the 3rd round starts, after mandatory login and consent in the option entry portal, CHOICE-3 candidates will be shown all the preferences/options entered by the candidates in the second round (except for the options rejected / cancelled by the candidate as allotted in the second round).

(d) Candidates can change the options or modify the priority numbers or remove any options if they are not required. The options that you remove will remain on your left side screen and such options will not be considered. That is, you can change any options or modify the priority

numbers or remove any options if they are not required.

Additional Instructions to Choice-3 candidates

• Candidates who have opted for CHOICE-3 will not be required to pay the fee for the seat allotted in the second round.

 After logging in and agreeing, candidates will be allowed to modify the options entered in the second round or remove any options if they do not want them.

 CHOICE-3 candidates will participate in the 3rd round by cancelling the seat allotted in the second round (without retaining it). Such candidates should opt for the seat only if any seat is allotted to them.

 Candidates are advised that if they decide that there are unnecessary options in their options list, they can delete such options in consultation with their parents.

Choice 4: I am Not satisfied with KEA allotted seat and I have got seat elsewhere, so I am quitting and not to be considered for allotment of seats in any of the further rounds. Implication: Not eligible to participate in the subsequent rounds and no hold on the allotted seat and seat allotted earlier will get cancelled.
