NOTIFICATION No. 144 -BOPEE of 2025 Dated 02-10-2025

In pursuance of Notification No. 143-BOPEE of 2025 dated 26-09-2025, the Board had notified the New Provisional Merit List for NEET UG Courses-2025 for inviting objections from the candidates figuring in the said merit list up to 28-09-2025 till 02.00 P.M. Since the Board had not received any genuine representation from any candidate, it is hereby notified for the information of all the eligible candidates that the online choice filling for 161 Govt. MBBS additional Seats in 05 Government Medical Colleges shall commence from 02-10-2025 (08:00 P.M. onwards) to 05-10-2025 (Midnight).

Candidates intending to submit the Preference Form for allotment of seats/colleges are required to deposit a non-refundable online fee of ₹1500. Any applicable bank transaction charges shall be borne solely by the applicant.

It is hereby clarified that failure to complete the online payment—due to any reason including technical errors or payment gateway issues—will render the candidate ineligible for consideration in the seat allotment process. No exceptions shall be entertained under any circumstances.

Candidates who have already paid the counselling fee in earlier rounds will not need to pay any fee again.

100 new MBBS seats of 02 Private colleges shall be filled in the 2nd round of counselling for filling of additional seats along with the shortfall/leftover of MBBS additional seats of 05 Government Medical Colleges.

Candidates who have submitted their deficient documents through email in pursuance of the above-referred notification, the Board, after thorough checking of the genuineness of the certificates, have cleared the deficiencies of these candidates only.

Candidates who have not submitted valid category certificates up to the last date fixed for making up deficiencies shall be considered in the Open Merit Category at the time of allotment of seats, if otherwise found eligible.

Candidates who have not submitted valid Sub-category certificates up to the last date fixed for making up deficiencies shall be considered in their respective main Categories at the time of allotment of seats, if otherwise found eligible.

All eligible candidates are strongly advised to thoroughly review the instructions outlined in the e-Counselling Guidelines before filling in their online choices. These guidelines, along with the e-Information Brochure, are accessible on the official website of the Board.

The Seat Matrix for the said course shall be available on the official website of the Board before the start of the process of online choice filling.

Mere filling up of online preferences shall not confer any right of admission to any candidate unless and until their eligibility is verified by the colleges/institutions concerned, and they will be provisionally selected.

The other Terms and Conditions shall remain the same as mentioned in the e-Information Brochure / Notifications / Notices issued by the Board from time to time in this regard.
