**Notification for exercising web options for 1<sup>st</sup> Phase of web based counseling for admission into MD (Homoeo) and MD/MS (Ayurveda) for the academic year 2025-26.**

In continuation of earlier Notifications dated 07.10.2025 the University hereby notifies the 1<sup>st</sup> Phase of web-based counselling for PG AYUSH i.e., MD (Homoeo) & MD/MS (Ayurveda) courses for the academic year 2025-26 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who are present in the Final Merit list notified in the website on **31.10.2025** are only eligible to exercise their options as per the seat matrix displayed on the **website** <https://drntr.uhsap.in>

The seat allocation will be done as per the Procedure given in G.O.Ms.No.603, HM & FW (R2) Dept., dt.23.12.2004 as amended in G.O.Ms.No.13, HM & FW(F2) Dept., dt.05.02.2021.

**UNIVERSITY FEE:** Candidates who are allotted with a seat, have to pay Rs.10,100/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

**TUTION FEE:** The selected candidates have to pay tuition fee and other constituent fee, special fee and caution money deposits at the rates laid down for the purpose from time to time subject to the conditions laid therein at the time of admission. The regulations governing the same will be informed.

**Instructions to Candidates:**

1. The candidates who secured their AIQ-PG seats through Round-I, II & III of AACCC – PG Counselling 2025, as announced by AACCC before release of allotments, if any, are not eligible to participate/allotment of seat in this counselling. If it is found that the in-eligible candidate participated in this counselling, candidature of such candidate will be cancelled and will not be permitted in further counsellings.
2. Area wise Seat Matrix is displayed in the University Website <https://drntr.uhsap.in> for information of the students. All the eligible candidates present in the Final Merit list displayed on **31.10.2025** are eligible to opt for Phase-I. If any new seats permitted before release of Phase-I allotments, those seats will be added and filled.
3. Candidates opting for PG (AYUSH) courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of specialities and colleges available.
4. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are genuinely interested.

5. The selected candidates have to login and to pay the University fee of ₹.10,100/- for downloading the Allotment Order by using Online payment method (Debit Card/Credit Card/Internet Banking) and report to the Principal of the Allotted College on or before the date specified in the allotment letter. University fee once paid is not refundable under any circumstances.
6. The selected candidates shall produce all the Original certificates, pay the Tuition fee, furnish necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
7. Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website:

8. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
9. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS) during subsequent Phases of counsellings, the original certificates will be sent to the college concerned after the closure of admissions.
10. Next Phase of counselling (exercising web options) will be conducted for:
  - a. Unfilled seats in Phase-I.
  - b. Not reported/Not joined seats of phase-I.

11. **Eligibility for Phase-II**

- a) Fresh options will be obtained from all the eligible candidates for Phase-II/ Final Phase of counselling.
- b) Reported Phase-I candidate can upgrade from Phase- I to Phase- II/Final Phase of Counselling **Candidates getting upgraded in Phase-II shall not have any claim on Phase-I seat.**
- c) If a candidate is allotted a seat in MD(Homoeo) & MD/MS(Ayurveda) courses as per his/her options and does not join the course under the Competent Authority Quota Phase-I counselling he/she is eligible for Phase- II/Final counselling.
- d) Candidates allotted seat in MD(Homoeo) & MD/MS(Ayurveda) courses under State/Central Counsellings of Phase-I or Phase-II, are not eligible in MOP-UP round of counselling.
- e) Phase-I seats vacated because of sliding to other colleges during the course of Phase-II/Final counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules.
- f) Candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
- g) Conversions will be conducted in this Phase-II/Final Phase counseling for filling up of the unfilled vacancies if any as per the rules.
- h) Candidates are informed to check their final allotment, take printout of allotment letter

from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.

- i) Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II/Final, but should download the allotted order if there is a change in Phase-II/Final
- j) As per G.O. Ms No.13, HM & FW (F2) Dept., dt. 05.02.2021, If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay of Rs. 50000/-+9000/-@18% GST (Rupees Fifty Nine thousand only) in the form of DD drawn in favour of the Registrar, Dr.NTR University of Health Sciences, A.P., Vijayawada.

12. The University fee once paid shall not be refunded under any circumstances.
