The schedule for State counselling CAP-3 round for MBBS/BDS was postponed as per the above referred Notice no.21. Now, the Medical Counselling Committee (MCC), New Delhi has revised the schedule for the All India Quota (AIQ) and State Quota Counselling , which is published on the official website of MCC on 23/10/2025.

- 2. Candidates who have cancelled/Not Joined an allotted seat in CAP-2 round need to unlock the CAP application form and submit form once again and make payment (as per the relevant quota of the candidate) from candidate login.
- 3. The choices filled by candidates for CAP Round 2 will be treated as null and void. All candidates participating in CAP Round 3 must fill fresh choices (preferences) for this round.
- 4. Candidates who had filled choices/preferences for CAP-3 as per the previous notice(Notice No 18, dated 04/10/2025) can edit their choices/preferences within the given schedule in table above.
- 5. Candidates must complete registration, make payment and upload all the requisite original scanned documents within the stipulated schedule.
- 6. Candidate allotted a seat in AIQ Round-3 will not be considered for CAP Round -3 and subsequent round/s for State counselling.
- 7. It is mandatory to join the allotted seat of CAP Round -3. Candidates who are allotted a seat in CAP Round-3 will not be considered for subsequnt rounds irrespective of whether they join or do not join to the allotted seat of CAP Round 3. Details of such candidates will be informed to MCC for further process and disqualification from AIQ rounds as per the Information Brochure.
- 8. Seats may increase due to cancellations of AIQ allotted candidates for round-3. Hence candidates are advised to take note of the same and exercise their choice filling carefully during the given period.
- 9. The remaining instruction will be remain same as given in Notice no.18 dated 04/10/2025.
