Notification for Exercising web options for 1st Phase of web-based counseling for admission into BNYS (Bachelor of Naturopathy and Yogic Sciences) course for the academic year 2025-26.

In continuation of earlier notifications dated 26.08.2025 & 06.09.2025 the University hereby notify the **1st Phase of Web-based counselling** for **BNYS course** under Competent Authority Quota seats for the Academic year 2025-26 in the BNYS Private colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who are present in the Final Merit list notified in the Website on 04.11.2025 are only eligible to exercise their options as per the Seat Matrix displayed on the Website <https://drntr.uhsap.in>

The seat allocation will be as per the Procedure given in G.O.P.No.646, Education (w) dept. Dt.10-07-1979 as amended in G.O.Ms.No.42, Higher Education dept., Dt.18-05-2009 and as per the G.O. Ms No.131 HM&FW (R2) Dept., dt:25.04.2008 as amended in G.O.Ms.No.8, HM & FW(F2) Dept., dt.29.01.2021.

UNIVERSITY FEE: Candidates who are allotted with a seat, have to pay **Rs. 8,600/-** before obtaining allotment letter through payment gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).

TUITION FEE: The selected candidates have to pay tuition fee of **Rs.24,500/-** per year for admission into UG AYUSH Courses as per orders of Government of Andhra Pradesh G.O.Ms.No.141 HM & FW(C2) Dept., dt.31.08.2023 & G.O.Ms.No.193 HM & FW(F2) Dept., dt.31.10.2023.

Instructions to the candidates: -

- Eligible candidates as per Provisional Final Merit position are only eligible for exercising web options in Private Un-aided BNYS Colleges.
- Candidates opting for BNYS degree course are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for available colleges if the candidates are interested to join as per eligibility.

3. Options:

- a. The eligible candidates present in the Final Merit Position displayed on **04.11.2025** should exercise options.
 - b. A candidate has to exercise options for the interested colleges in the order of priority.
 - c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.
 - d. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
 - e. Candidates are instructed to take the print out of the saved options.
4. The allotment of seats is as per G.O.Ms.No.8, dt.29-01-2021, merit list and order of priority of options given by the candidate.
 5. Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website: <https://apuhs-ugadmissions.aptonline.in/ugbnys/home/home> for status of allotment.
 6. Candidates who have been allotted a seat shall report at the allotted college within the reporting schedule by downloading the allotment order on payment of University fee of Rs. 8,600/-.
 7. The selected candidates have to submit all the original certificates, pay the Tuition fee, and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
 8. **If not allotted any seat in Phase-I:** Candidates who have not been allotted any seat in the Phase-I of counselling will be considered for available vacancies in Phase-II of counselling with fresh Options.
 9. **If not reported at the allotted college:** The candidates who do not report at the allotted college in the Phase-I counselling, will be allowed to participate in the Phase-II counselling with fresh options, provided that the candidates have no right to claim earlier Phase-I allotted seat again under Phase-II counselling.
 10. If the joined candidates of Phase-I slides to other college during Phase-II of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the reallocated college with downloaded allotment order along with Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
 11. Candidates getting upgraded in Phase-II of Counselling will not have any claim on previous allotments, i.e., Phase-I seat as the vacancies resulting from upgradation are filled within this phase by the next candidate in the merit list with rules of reservation as applicable.
 12. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr. NTR UHS) during subsequent phases of counselling, the original certificates will be sent to the college concerned by the college where the candidate has slide.
 13. The 2nd/Final phase counselling (exercising web options) will be conducted after the closure of reporting time of 1st phase allotments for the available vacancies: -
 - a. Unfilled seats in Phase-I
 - b. Not reported seats in Phase-I

14. **The University fee once paid shall not be refunded under any circumstances.**
