Notification for exercising Web Options for the 2nd Phase of web-based counselling for admission into B.Sc.(Nursing) 4-YD Course under Competent Authority Quota seats for the Academic Year 2025-26.

In continuation to the Provisional Final Merit List displayed on 18.10.2025, this University hereby notifies the 2nd phase of web-based counselling for Admission into B.Sc. (Nursing) 4-YD Course to fill-up the seats under Competent Authority Quota for the existing vacancies and Not Reported seats of first phase counselling and seats in the newly affiliated colleges in above course.

Instructions to Candidates:

- 1. The candidates, whose names are present in the Final Merit List displayed after verification of copies of Original Certificates and addendum issued thereafter if any, are only eligible to exercise web options.
- 2. The candidates, who secured admission in 1st counselling and wish to change their college according to their merit, can exercise their web options. The candidates who have not joined in the colleges allotted and not allotted any college during the Phase-I counselling can also exercise web options in the Phase-II of counselling.
- **3.** Candidates are advised to exercise web options as per their choice irrespective of the vacancies.
- **4.** The second phase of counselling will be conducted for the following vacancies:

a.	Unfilled seats after phase – I	-	1978
В.	Non-joining of the candidates in phase - I	-	2762
c.	Seats in the newly permitted colleges	-	744
d.	The vacancies that may arise during the process of phase – II counselling.		

- 5. All vacancies available as on that date of release of allotments will be filled.
- 6. Candidates while giving options should note that the seats vacated by the candidates selected in first counseling and slided to other college will be added & allotted simultaneously during this counseling. The allotted seat in Phase-I counseling will be cancelled automatically on allotment of other college as per their option in Phase-II.
- 7. Other conditions specified in notification dated 26.08.2025 remain the same.
- 8. The colleges newly permitted are included in the 2nd Phase of counselling (Annexure-I enclosed)

Note: Candidates are informed to exercise options for all colleges as per their choice in the preferential order irrespective of vacancies. No limit for exercising options.

9. University Fee:

₹. 5,600/- (Rupees Five thousand Six hundred only). The Selected Candidates have to pay non-refundable University fee through payment gateway using online payment method (Debit Card/Credit Card/Internet Banking) and applicable bank charges for downloading allotment order.

10. Tuition Fee:

As fixed by the Government for Government colleges/Unaided Non-Minority and Minority Colleges.

11. All the Eligible Indian National candidates who have got their uploaded copies of certificates verified and whose names are present in the Provisional Final Merit List displayed on 18-10-2025 can exercise their Web Options as per the seat matrix which will be displayed in the website https://drntr.uhsap.in.

The allotment of seats is as per the following Government Orders:

- a. G.O.P.No.646, Education (w) Department, dated 10.07.1979
- b. G.O.Ms.No.42, Higher Education Department, dated. 18.05.2009.
- c. G.O.Rt.No.550, Higher Education (EC.2) Department dated.30.07.2001
- d. G.O.Rt.No.111, Higher Education (E.C) Department dated.13.08.2019 and
- e. G.O.Rt.No.159, Higher Education (E.C) Department, Dated.13.11.2020.
- 13. All unfilled seats under PwD quota will be converted and added to respective categories, since the seats under special category are Horizontal Reservation.

14. Reporting at the allotted college:

- a) Candidates will receive the message to their registered mobile after allotment of seat, if seat is allotted. The candidates are instructed to visit the Website: https://drntr.uhsap.in for status of allotment after closure of Web Options.
- b) Candidates who have been allotted a seat shall report at the allotted college within the reporting schedule by downloading the allotment order on payment of University fee as specified with all Original Certificates and pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
- c) Verification of Original Certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.

d) If not allotted any seat in Phase-II:

Candidates who have not been allotted any seat in the Phase-II of counselling will be considered for available vacancies in Phase-III of counselling with fresh Options.

e) If not reported at the allotted college:

The candidates who do not report at the allotted college in the Phase-II counselling, will be allowed to participate in the Phase-III counselling with fresh options, provided that the candidates have no right to claim earlier Phase-II allotted seat again under Phase-III counselling.

- f) If the joined candidates of Phase-I slides to other college during Phase-II of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order alongwith Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
- g) Candidates getting upgraded in Phase-II of Counselling will not have any claim on previous allotments, i.e., Phase-I seat as the vacancies resulting from upgradation are filled within this phase by the next candidate in the merit list with rules of reservation as applicable.
- 15. Candidates are advised to read the regulations and prospectus of Dr. NTR UHS available on Website carefully before exercising web options.
- 16. Candidates can exercise options to all colleges to which they are eligible. The allotment of seats will be as per the order of priorities/options given by the candidate. There is no limit for the number of options.

Minority Seats in College of Nursing, CMC, Vellore, Chittoor campus will be allotted to Christian Minority Candidates only.

17. Candidates can exercise web options from any place having internet facility through https://apuhs-ugadmissions.aptonline.in/UGNRFY/Home/StudentLogin. Use only

system with Internet Explorer versions 11 or above. One Time Password will be sent to the registered mobile number at the time of saving Web options.DO NOT USE TABS OR MOBILES TO EXERCISE WEB OPTIONS.

Candidate can exercise web options.

-) Selected Options can be slided either up or down, added and deleted.
- II) Web options opted must be saved by the candidate.
- III) Web options once submitted cannot be edited.
- IV) Web options saved but not submitted until the cut-off date and time will be Auto submitted.
- 18. Candidates are instructed to take a print-out of saved options.
- 19. Candidates have to check website https://drntr.uhsap.in for allotment of seats after closure of date of exercising options for status of allotment.
- 20. Candidate has to download the allotment letter by paying the University Fee through payment gateway.
- 21. Candidate has to take print-out of allotment order. Check their allotment and report to the Principal of respective college before the date specified on the allotment letter.
- 22. The selected candidates shall report to the Principal with all original certificates, allotment order and Provisional Verification form, pay the College fee before the last date and time at the allotted college as mentioned in the allotment letter.
- 23. The University Fee once paid shall not be refunded under any circumstances.
- 24. Next rounds of counseling will be conducted for :
 - a. Leftover seats in Phase II
 - b. Not reported / Not joined seats after Phase-II
 - c. Seats added, if any
