 The NEET - PG MEDICAL Information Brochure is available on the CENTAC website <u>www.centacpuducherry.in</u>. Candidates are advised to download the Information Brochure and read it carefully before filling the ONLINE application form. In the event of rejection of

- an incomplete application form, request for re-consideration will NOT be entertained.
- 2. This brochure is an information booklet alone. The guidelines contained are subject to modifications as per instructions received from time to time from the Government or Statutory bodies. 3. The entire counselling process from submitting application until admission will be made through ONLINE MODE ONLY.
- 4. Candidates are advised to fill the application form on their own and not through any agent or third party.
- 5. A candidate can submit only ONE NEET- PG MEDICAL application. Any candidate found to have submitted more than one application for NEET- PG MEDICAL shall be debarred from the NEET-PG MEDICAL Counselling process and his / her candidature shall be cancelled.
- Submission of application will be only through the CENTAC website <u>www.centacpuducherry.in</u>. Candidates should check the website regularly for updates until the completion of the admission process.
- 7. An exclusive mobile number and an email id of either the candidate or the parent / guardian of the candidate is an absolute necessity. The access to the candidate's dashboard can only be made through OTP validation that is sent to the candidate's registered mobile number. Candidates are advised to use the same mobile number till all the admissions are over.
- 8. Candidates must ensure that the e-mail address and Mobile Number provided in the Online Application Form are their own or of their Parents / Guardian only, as all communications with regard to the counselling process will be sent to the candidate through SMS on the registered Mobile Number only.
- 9. All communication with the candidate will be only through SMS sent to the candidate's registered mobile number or sometimes through email, should there arise a necessity for individual communication. Candidates should also regularly check the NOTICES / PRESS RELEASES that will be uploaded on the website from time to time.
- 10. CENTAC will not be responsible for consequences due to non-follow up of NOTICES / PRESS RELEASES published on the website regarding counselling to NEET PG -MEDICAL courses for the Academic Year 2025-2026. Hence, candidates should regularly check the NOTICES / PRESS RELEASES that will be uploaded on the website for updates.

- 11. The documents that are required in digital format to be uploaded along with the application are given in Part I, Clause 12 of the NEET PG MEDICAL Information Brochure.
- 12. For information on Reservation of Seats for various categories, refer Part I, Clause 9 of the NEET PG - MEDICAL Information Brochure. The details of category-wise reservation (No. of seats) can be viewed from the Seat Matrix that will be uploaded separately on the CENTAC website.

- 13. Application submission comprises entering of Personal Details, Academic Information, Uploading of Documents, Payment of Fees and Submission of Course Preferences.
- 14. For information on Submission of Course Preferences refer Part I, Clause 16 of the NEET PG - MEDICAL Information Brochure. Failure to enter Course Preferences (at least ONE), will result in non-allotment of a seat. Course preferences once submitted for a Round will be final.
- 15. Candidates are advised to choose as many course preferences as may be possible. This would facilitate in securing admission to an alternate course / college, in case the candidate is not able to secure admission of the first choice.
- 16. Candidates are advised to go through the details of Tuition Fee notified by the Health Department published on the CENTAC website. The Tuition Fee for NEET PG MEDICAL courses should be paid to CENTAC through the ONLINE mode only.
- 17. Candidates are also advised to visit the college website or contact the college authorities directly for any query regarding additional fee / bond before filling choices.
- 18. The candidate will be able to edit the entries made by him / her including personal details and course preferences till the last date permitted for submission of online application. After the last date, the data will be frozen with no further modifications possible. For the last date of submission of Online application refer NOTICES / PRESS RELEASES published in the CENTAC website www.centacpuducherry.in.
- 19. MERIT LISTS / ELIGIBLE LISTS and ALLOTMENT LISTS for each Round will be available on the website and the results WILL NOT BE COMMUNICATED INDIVIDUALLY. 20. It is mandatory for the allotted candidate to physically report to the college along with the original documents and pay the prescribed fees so as to confirm the allotted seat. No other person in the place of the candidate will be allowed to submit the documents and take admission on behalf of the candidate.





1. INTRODUCTION

The counselling for allotment of candidates to PG Medical (M.D. / M.S.) courses for the year 2025-26 will be done by the State Counselling Authority - CENTAC. All admissions to PG Medical courses will be done as per the relevant norms / guidelines / regulations notified by the concerned Regulatory Bodies.

Under the regulations framed by the Indian Medical Council Act, 1956, admissions to Postgraduate Medical courses (M.D. / M.S.) in medical colleges affiliated to Pondicherry University and approved by the Medical Council of India will be based on the NEET PG Medical 2025 examination. The admissions for the Academic Year 2025–26 will be carried out by CENTAC, considering the NEET PG Medical 2025 score and rank.

The candidate should have passed the final M.B.B.S. examination from a recognized Institution / University and must have satisfactorily completed One Year Compulsory Rotatory Residential Internship (CRRI) as on 31st July 2025 and must submit their internship completion certificate at the time of admission.

4. MODE OF APPLICATION

Application must be submitted ONLINE ONLY through the website www.centacpuducherry.in.

A candidate can submit only ONE NEET PG - MEDICAL application.

Candidate should ensure that all information entered during the online registration process is correct. Information provided by the candidate such as name of candidate, contact address, category, educational qualification, marks, date of birth, etc., will be

treated as correct. The CENTAC will not entertain any request for change after the Last Date for submitting applications.

Physical applications will not be accepted.

If a duplicate application is found, both the applications will be rejected and his / her candidature will be cancelled.

Entering of false information by the candidate will result in rejection of the application.

The candidate will be able to make necessary updates even after the publication of the First List (Draft Merit List) and Second List (Revised Draft Merit List), but before publication of Third List (Final Merit List).

The CENTAC will not entertain any request for change in the information after publication of the Final Merit List.

a) Before filling the application, read the NEET PG – MEDICAL Information Brochure for the year 2025-26 available on the CENTAC website, carefully. Candidates are deemed to have read, agreed and accepted the process of counselling and the terms and conditions laid down by the CENTAC for the NEET PG - MEDICAL Counselling.

- b) Mere submission of application does not confer any automatic right to secure a seat. The allotment of a seat is subject to fulfilling the merit, admission criteria, eligibility, and such criteria as may be prescribed by concerned regulatory bodies / affiliating University, NMC / MCC and the State / Central Government.
- c) Candidates are advised to check the Tuition Fee structure on the CENTAC website and confirm any additional fees with the respective colleges, particularly Private Colleges, before submitting their course preferences. It is the responsibility of the candidate to verify the fee details in advance, as CENTAC will not be held accountable for any additional fee charged by the colleges and will not entertain requests or complaints in this matter. Candidates must ensure the accuracy of the fee information before filling up the course preferences. Course preferences once submitted by the candidate cannot be altered and no request for modification in course preference will be considered by CENTAC after the prescribed deadline.
- d) Application for NEET PG MEDICAL Counselling can only be submitted online through the CENTAC website www.centacpuducherry.in. Application submitted through any other mode shall not be entertained.


5. MODE OF COMMUNICATION

- a) The candidate will be informed of all the rounds of counselling of CENTAC through SMS and the same will also be published on the CENTAC website through NOTICES / PRESS RELEASES. After the online application is opened, the candidate should refer to the CENTAC website www.centacpuducherry.in, regularly.
- b) The candidate must ensure that the mobile numbers and e-mail address entered in the online application form are his / her own, as the CENTAC will send information / communication by SMS to the registered mobile numbers only, and if required, through the registered email address. Candidates are advised to check their SMS messages and emails REGULARLY. It is also advised that the candidate registers an alternate mobile number to which he / she has got access.
- c) No individual communication will be sent to any of the candidate regarding the counselling process, other than the SMS. - 7.2 Minority Management Quota Seats in Private Medical Colleges
- a) In Round 1, Round 2 and Round 3 Minority Management Quota seats for M.D. / M.S. in SVMCH&RC, Puducherry will be available for counselling for Residents of U.T. of Puducherry only.
- b) For Minority Management Quota seats in SVMCH&RI, candidates who are residents of the U.T. of Puducherry and belonging to Telugu Linguistic Minority alone are eligible.
- c) U.T. of Puducherry candidates claiming seats under Telugu Minority Management Quota should produce valid proof like Transfer Certificate (TC) to prove that his / her mother tongue is TELUGU. If mother tongue "TELUGU" is not mentioned in the Transfer Certificate attach certificate as per Annexure 7.
- 8. ELIGIBILITY CRITERIA OF CANDIDATES
- 8.1 NATIONALITY CRITERIA
- a) A candidate seeking admission for Government Quota, Other State Quota, Management Quota and Self-supporting Quota through CENTAC should be an Indian National. However, French Nationals residing in the U.T. of Puducherry and covered by the terms of the Treaty of Cession shall be treated on par with Indian Nationals, for the purpose of admission to all

the courses.

b) In terms of instructions of the Ministry of External Affairs, Govt. of India, Non-Resident Indians are entitled to all benefits available to Indian Nationals subject to such notifications that would be issued by the Government from time-to-time.

8.1.1 RESIDENCE CRITERIA

- A) RESIDENTS OF THE U.T. OF PUDUCHERRY
- (G.O. Ms. No. 64 dated 25th May 2006).

An applicant is considered to be a Puducherry Resident if he / she is an Indian National and satisfies at least ONE of the following criteria:

1. The candidate or whose parent (either Mother or Father or Both) or Guardian (in case of children who have lost both parents) has been residing continuously in the U.T. of Puducherry for at least five years preceding the date of application.

(OR)

2. Those who have passed the SSLC / HSC or any other public examination and for that purpose had undergone academic studies continuously for 5 successive classes immediately preceding the qualifying examination (including the year of qualifying examination) in a recognized educational institution located in the U.T. of Puducherry and having their residence in the U.T. Puducherry for 5

CENTAC 2025 – GENERAL INFORMATION – NEET PG MEDICAL Page 17 years continuously during that period. Mere stay in places such as residential hostel would not amount to residence.

(OR)

- 3. Children of natives of the U.T. of Puducherry who have declared any place in the U.T. of Puducherry as their home town and so certified by their respective Heads of Office. (OR)
- 4. a) Children whose parents are Central / State Government Servants / Defence Personnel / Central Paramilitary Forces / Employees of Public Sector Undertakings wholly or substantially owned either by the Central Government or by the Puducherry Administration posted and serving in U.T. of Puducherry for at least a minimum continuous period of three years immediately prior to the last date of submission of application.

(AND)

b) Children of the above said employees should have studied HSC of two years in any of the schools in the U.T. of Puducherry and should have passed the qualifying examinations (HSC) from the same school. {G.O. Ms. No. 04, Puducherry dated 09.02.2016 of the Chief Secretariat (Hr. & Tech. Edn.)}, Puducherry.

(OR)

5. Children of Defence Personnel who were killed or disabled in action and children of Central Government Servants / U.T. of Puducherry Government Servants / Defence Personnel / Employees of Public Sector Undertakings wholly or substantially run either by the Central Government or by the U.T. of Puducherry Administration who died while in service in the U.T. of Puducherry.

6. French Nationals residing in the U.T. of Puducherry and covered by the terms of the "Treaty of Cession" shall be treated on par with the candidates who produce the prescribed U.T. of Puducherry Residence Certificate. Such French Nationals will not be required to produce Residence Certificate; instead, they should produce a "Certificate of Registration" issued for this purpose by the French Consulate at Puducherry. Children of these French Nationals shall not be considered for admission under the Non-Resident quota.

B) OTHER STATES

"Other States" refers to students who are Indian Nationals and not Residents of the Union Territory of Puducherry.

8.1.2 DUAL NATIVITY CLAIM

Candidates seeking admission to NEET-based Undergraduate (UG) or Postgraduate (PG) Medical and Dental courses through CENTAC are required to submit a sworn affidavit. This affidavit, to be signed by the candidate's parent or guardian, must affirm that the candidate has not availed or

CENTAC 2025 – GENERAL INFORMATION – NEET PG MEDICAL Page 18 claimed the benefit of residence for admission under the State Quota in any State or Union Territory (UT) other than the Union Territory of Puducherry.

Certain States extend the benefit of reservation under the Government Quota to students who, while not residents of that State, qualify as natives or persons of origin from the State. The Union Territory of Puducherry permits admission under its Government Quota to such candidates, provided they have not opted for or claimed Government Quota seats in any other State or U.T.

Accordingly, a candidate who satisfies the residence or native eligibility criteria in both the Union Territory of Puducherry and any other State / U.T. must exercise a choice. Such candidates are entitled to seek Government Quota admission either in the U.T. of Puducherry or in the other State / U.T. where they hold eligibility, but not in both.

This scenario, wherein a candidate qualifies as a resident or native of more than one State or U.T. in India, typically due to birth, prolonged residence, or ancestral origin, is referred to as "dual nativity." Candidates possessing dual nativity who have opted for Government Quota admission in any State or U.T. other than the U.T. of Puducherry is precluded from applying to Government Quota seats in the U.T. of Puducherry.

Consequences of Dual Nativity:

Candidates who are found to possess dual nativity and who have applied for Government Quota seats in a State or Union Territory (U.T.) in addition to the Union Territory of Puducherry will be, in violation of the stipulated guidelines, shall face consequences, such as cancellation of admission and potential legal action. The candidate would be liable to face the following repercussions: -

- Cancellation of Admission: Any admission secured on the basis of misrepresented nativity status will be deemed invalid and cancelled forthwith.
- Legal Action: Candidates shall face legal proceedings, including potential criminal charges, for willful misrepresentation or submission of false information.
- Disqualification: Such candidates will be debarred from participating in the ongoing and future counselling processes conducted by CENTAC.

Preventive Measures Against Dual Nativity

To avoid disqualification and related consequences, candidates are advised to strictly adhere to the following preventive measures:

- Exclusive Application: Apply for Government Quota seats only in one jurisdiction—either in the Union Territory of Puducherry or in any other State / U.T. where the candidate qualifies under the respective nativity / residency policy.
- Authentic Documentation: Submit only genuine and verifiable documents in support of nativity and residency claims.
- Honest Disclosure: Ensure that all information provided, particularly related to nativity, is accurate, current, and free from discrepancies.

10. RESERVATION ALGORITHM FOR GOVERNMENT QUOTA SEATS

10.1 MODE OF RESERVATION

The Mode of Reservation while allotting the seats will be as follows:

- All the candidates should be Indian Nationals and Residents of Puducherry. Vertical Reservation on Regional basis will be made in the first instance (UR, EWS, OBC, MBC, EBC, BCM, SC, ST, BT) as per the Seat Matrix.
- Horizontal Reservation (FF/ ESM / PwD / MSP) will be done if adequate seats are not filled after fixing vertical and regional reservation, i.e., if the requisite seats are not filled while doing vertical reservation, the last candidates in the respective categories will be replaced as per merit. An Example for Filling Horizontal Reservation:

If 5 seats need to be filled under the Persons with Disabilities (PwD) quota, and if 4 PwD candidates are already accommodated in the Vertical Reservation as per merit, then only 1 PwD candidate will be accommodated into the list by replacing the last candidate as per reservation. If the 5th PwD candidate belongs to the BCM category, then the last candidate in the BCM category will be replaced by this candidate.

10.2 CONVERSION OF SEATS

- 10.2.1 Conversion of Minority Management Quota Seats
- a) In Round 1 and Round 2, the Minority Management Quota seats in SVMCH&RC (M.D./

M.S. – MQT) will be available only for Residents of U.T. of Puducherry candidates who are in the Telugu Minority Merit List. Accordingly, the course preferences will be enabled for the Minority candidates only.

b) In Round 3, after exhausting the entire Telugu Minority Merit List of candidates, the unfilled Minority Management Quota seats will be converted to All India Management Quota Seats in Round 3 itself. Hence, both the Minority Management Quota course preferences (MQT) and All India Management Quota course preferences (MQ) in SVMCH&RC will be enabled.

10.3 De-RESERVATION OF SEATS

With respect to Government Quota seats, if any seat in the RESERVED category (OBC / MBC / EBC / BCM / SC / ST / BT) remains vacant, the same will be de-reserved and converted into the UNRESERVED category as per the Seats Conversion Algorithm in Annexure – 10 and offered for counselling in Round 3.

3) Scheduled Castes (SC)

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Caste under "The Constitution (Pondicherry) Scheduled Castes Order 1964" dated 05.03.1964, read with "The Constitution (Scheduled Caste) orders (Second Amendment) Act 2002 (Central Act 61 of 2002) and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

4) Scheduled Tribes (ST)

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Tribe under "The Constitution (Puducherry) Scheduled Tribes Order, 2016" dated 22.12.2016 and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

10.4.2 U.T. OF PUDUCHERRY - HORIZONTAL RESERVATION

1) Freedom Fighter (FF)

Candidates claiming admission under this category should be Children / Grand Children of Freedom Fighters and they should enclose the necessary certificate issued by the Officer-in-charge, Freedom

Fighters Cell, Government of Puducherry.

2) Wards of Ex-servicemen (ESM)

Those who are registered as Ex-servicemen in the Department of Sainik Welfare (DSW), Government of Puducherry and have got an Ex-servicemen / Widow of Ex-servicemen identity card from the DSW should enclose the necessary certificate issued by the Director, DSW, Puducherry.

3) Persons with Disabilities (PwD)

- a) The "Certificate of Disability" shall be issued in accordance with the Rights of Persons with Disabilities Rules, 2017 notified in the Gazette of India by the Ministry of Social Justice and Empowerment (Department of Empowerment of Persons with Disabilities on 15th June 2017).
- b) The extent of "specified disability" in a person shall be assessed in accordance with the "Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016 (49 of 2016) notified in the Gazette of India by the Ministry of Social Justice and Empowerment on 4th January 2018.
- c) The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability. (As per MCI Gazette Notification No. MCI-18(1)/2018-Med./187262 dated 5th Feb, 2019/14th May, 2019).

Further: Candidates seeking admission to PG Medical courses under this category will be required to undergo a second medical examination by a Medical Board constituted for the purpose by the Directorate of Health and Family Welfare Services, Government of Puducherry, to ascertain and confirm the nature and extent of the physical disability. The decision of the Directorate of Health and Family Welfare Services, Government of Puducherry, in this regard, will be final.

In case, the cut-off marks for NEET PG - 2025 is lowered by the MCC / MoHFW, then fresh applications will be invited.

19. NUMBER OF ROUNDS OF ONLINE COUNSELLING

Counselling will be done as per the guidelines received from the MCC. Allotment to M.D. / M.S. is based on the NEET PG – 2025 Rank. There are FOUR Rounds of ONLINE counselling: 1. Round 1

- 2. Round 2
- 3. Round 3
- 4. Stray Round

Each round of counselling is a separate round and the rules of each round are different. Once any round commences, the rules of that round will apply to all the candidates even if they were allotted / admitted in the previous round(s) of counselling.

Case 2: Resigning Before Round 3 Registration:

A candidate admitted in Round 1 or Round 2 can resign from the seat before Round 3 registration after which time, the candidate will not be allowed to vacate the admitted seat.

LETTER FOR SEAT RESIGNATION:

- a) A candidate who wants to resign his / her admitted seat as per Case 1 and Case 2, should submit his / her request for resignation in the Online Mode only. The format of the Letter for Resignation is available in Annexure 11. After due approval from the Counselling Authority, the Letter of Resignation should be countersigned by the Coordinator / Convenor. The same should be submitted to the concerned college after which the candidate can collect the "No Objection Certificate (NOC)" from the concerned college. Candidate should also upload the countersigned Letter of Resignation through the link available in the candidate's dashboard.
- b) No college has the authority to permit the resignation of the candidate and issue "No

Objection Certificate (NOC)". Only the counselling authority CENTAC, after due permission from the competent authority can permit the resignation of the candidate.

20. PROVISIONAL ALLOTMENT

Upon completion of the allotment process, the Provisional Allotment List will be published on the CENTAC website. All seat allotments are provisional in nature. CENTAC reserves the right to withdraw any allotment at any stage if it is found that the candidate does not fulfill the eligibility criteria or other regulations prescribed by the competent authority from time to time.

"Eligibility, admissions, and allotments made to and by the colleges shall be subject to the approval of the regulatory bodies, such as NMC / MCC / Pondicherry University / Apex Bodies, etc. CENTAC and the Government of Puducherry reserve the right to conduct verification, at any stage, into the originality and authenticity of the certificates submitted by any candidate in support of his / her qualifying or eligibility claims. If, upon such verification, it is found that a candidate has produced fake or fraudulent certificates, or has obtained certificates by suppressing facts, he / she shall be liable to criminal prosecution, immediate cancellation of the allotted seat without notice, forfeiture of all fees paid, and imposition of penalty as prescribed by the competent authority. Further, such candidates may be debarred from all future examinations and counselling processes, and the concerned authorities may also recommend blacklisting to the NMC / MCC / Pondicherry University / Apex Bodies, as well as cancellation of medical license."

21. JOINING THE COLLEGE

Once the Provisional Allotment is done, the candidate must download the Provisional Allotment Order and report to the allotted college within the specified time. If the candidate does not report within the given time, the provisional allotment will be automatically cancelled. The similar procedure will be followed for all the rounds of counselling.

The candidate is required to submit a printout of the CENTAC Application Form, Provisional Allotment Letter and Original Certificates along with self-attested photocopies of all the required documents at the time of admission with the prescribed fee for payment.

Important Note to Candidates:

a) If CENTAC / College or other Authorities find that admission has been offered based on NOT fulfilling the minimum eligibility requirements / false or incorrect information / documents and suppression of relevant fact, education qualification or quota, the allotment / admission offered will be summarily cancelled, irrespective of the stage of study of that

course and the fees paid shall not be refunded in any case. Further, legal proceedings will also be initiated against such candidates for such actions. Hence, candidates are warned against indulging in such practices, in their own interest.
