## 1)SECURITY DEPOSIT:

As already notified, the eligible candidates who are willing to participate in Phase-III counselling under Management Quota have to pay a **Refundable Security Deposit Amount of Rs.3,00,000/-(Rupees three lakhs only)** through online mode before exercising web options, subject to the conditions:

- i. Refundable Security Deposit of candidates who do not join the seats allotted to them in Phase-III, if any, will be forfeited.
- ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iv. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).

### 2) INSTRUCTIONS TO THE CANDIDATES:

- 1. Subject to the conditions laid down in the Information on Counselling Procedure, the same application will be considered for all the rounds of stray vacancy counseling.
- **2.** The Application submitted for Competent Authority (Convenor) Quota seats <u>WILL NOT BE</u> considered for Management Quota seats.
- 3. The online application must be filled from a desktop or laptop with internet connection.
- **4.** The Application and Processing fee including verification fee including late fees, if any once paid will not be refunded or adjusted to a further date. The fee is non–refundable. Hence, interested candidates are advised to check their eligibility before applying.
- 5. The Provisional Final merit position will be displayed on the University website after verification of uploaded scanned original certificates.
- 6. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2025 Rank.
- 7. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
- 8. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
- 9. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
