Information/Eligibility regarding Stray Vacancy Round

2. **If not allotted any seat:** Candidates who are not holding any seat of BHMS/BAMS/BUMS of Central quota or State quota are only eligible to apply under this notification.
3. All the eligible candidates who are in the Merit list notified in the website on **10.10.2025** eligible to exercise their options.

Information/Not Eligibility regarding Stray Vacancy Round

4. The Candidates who are holding seat **of Central quota or State quota** are not eligible to Participate in Stray Vacancy Round of counselling.
5. Candidates allotted in Phase-III are not eligible to Participate in Stray Vacancy Round of counselling.
6. **If the candidate is allotted a seat under this notification, he / she has to report in the allotted college compulsorily.**
