In continuation of earlier notifications, dated 06.12.2025 this University hereby notifies the Phase-II/Final web-based counselling for MPT courses for the academic year 2025-26 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who are present in the Final Merit list notified in the website on **05.01.2026 & 09.01.2026** are only eligible to exercise their web options as per the seat matrix displayed on the website <https://drntr.uhsap.in>

Instructions to Candidates:

1. Vacancy position is displayed on University website for information of the students to exercise their options.
2. The following are the vacancies available for Competent Authority Quota Phase-II/Final Counselling

3. Fresh options will be obtained from all the eligible candidates for Phase-II/ Final Phase of counselling.
4. Reported Phase-I candidate can upgrade from Phase- I to Phase- II/Final Phase of Counselling **Candidates getting upgraded in Phase-II shall not have any claim on Phase-I seat.**
5. If a candidate is allotted a seat in MPT courses as per his/her options and does not join the course under the Competent Authority Quota Phase-I counselling he/she is eligible for Phase- II/Final counselling.

6. Phase-I seats vacated because of sliding to other colleges during the course of Phase-II/Final counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules.
7. Candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
8. Conversions will be conducted in this Phase-II/Final Phase counselling for filling up of the unfilled vacancies if any as per the rules.
9. Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website:

10. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can view the college wise list of selected candidates in the website.

UNIVERSITY FEE: Candidates who are allotted a seat, have to pay Rs.12,900/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

TUTION FEE: As fixed by the Government of Andhra Pradesh.

- **Note: The University fee once paid shall not be refunded under any circumstances.**
 - Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II/Final, but should download the allotted order if there is a change in Phase-II/Final.
 - The selected candidates are informed to check their final allotment, take printout of allotment letter from the student login and report to the respective colleges on or before the date specified on the allotment letter and shall produce all original certificates and pay the tuition fee and furnish bonds etc., if any to complete the admission process.
 - In case, if the candidate fails to report before the date/time given at allotted college or fail to fulfil the eligibility criteria as per Regulation, their admission will be cancelled automatically.
11. The Original certificates will be verified at the time of admission in the respective college and in case of any discrepancy or found ineligible as per the regulations the Provisional allotment will be cancelled. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS) during subsequent Phases of counsellings, the original certificates will be sent to the college concerned after the closure of admissions.

Mop-Up Round Counselling:

1. Counselling for Mop-Up Round will be done for the unfilled seats if any after Phase-II
2. Candidates allotted seat in MPT course as per his/her options under the Competent Authority Quota in any phase of counselling are not eligible for Mop-up Round of counselling to prevent seat blocking.
