Notification for exercising web options for MOP-UP Round of web based counseling for admission into MPT courses for the academic year 2025-26 .

In continuation to the earlier notifications, dated 05.01.2026,16.02.2026 & 26.02.2026, this University hereby notify the MOP-UP Round of web-based counselling for MPT courses for the academic year 2025-26 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

Instructions to Candidates:

1. All the eligible candidates who are present in the Final Merit list notified in the website on **05.01.2026 & 09.01.2026** and **who were not allotted a seat either in Phase-I or Phase-II/Final counselling** are only eligible to exercise their web options.
2. As all the unfilled vacancies in 2nd & Final Phase Counseling are converted and filled as per conversion rules in that phase. Hence, all the available vacancies are treated as **“Unreserved Open General seats”**.
3. Fresh options will be obtained from all the eligible candidates.
4. Vacancy position is displayed on University website for the information of the students to exercise their options.
5. Candidates are instructed to be careful while exercising options on the Web and give your options for the Colleges/Specialities actually interested to avoid wastage of seat and take the print out of the saved options.
6. The candidates who get allotment in this MOPUP Round Counseling should join compulsorily in the allotted college.
7. Candidates will receive the seat allotment message to their registered mobile, if seat is allotted. The candidates are also instructed to visit the website for status of allotment. <https://apuhs-pgadmissions.aptonline.in/PGMPT/Home/StudentLogin>
8. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.

UNIVERSITY FEE: Candidates who are allotted a seat, have to pay Rs.12,900/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

TUTION FEE: As fixed by the Government of Andhra Pradesh

9. Candidates are informed to check their final allotment, take printout of allotment letter from the website and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the allotted seat will automatically be cancelled.
10. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.
11. **The University fee once paid shall not be refunded under any circumstances.**
12. **If any candidate wish to discontinue their course, after closure of the admission (or) in the middle of the course have to pay an amount of Rs. 25000/- (Rupees Twenty Five Thousand only) towards Discontinuation fee.**
