Consequent upon the declaration of the Result/Provisional Merit List of the Common Entrance Test for admission to GNM/ANM Courses-2026 vide Notification No. 076-BOPEE of 2026 Dated: 02-06-2026, it is hereby notified for information of all the concerned candidates that the Board shall conduct the First Round of Online Counselling for admission to GNM/ANM Courses-2026 w.e.f **15-07-2026 (11:30 AM onwards) to 18-07-2026**.

It is for the information for all the candidates that the seats shall be allotted on the basis of the credentials of the candidates mentioned in the **Annexure-A** to the Notification No. 076-BOPEE of 2026 Dated: 02-06-2026. The Board shall in no case be held responsible, if a seat is allotted to any of such candidates on the basis of wrong category mentioned in online application form.

Note:

1. No representation shall be accepted /entertained by the Board through any E-mail or WhatsApp mode.
2. The process of online filling up of choices/preferences shall be available w.e.f. **15-07-2026 (11:30 AM onwards) to 18-07-2026** and the instructions related to filling up of online Choices/Preferences have already been mentioned in the Counselling Procedure which is available on official website of the Board (www.jkbopee.gov.in) only.
3. Further the candidates shall have to pay online counseling fee of **Rs. 1000/-** as mentioned in e-Information Brochure/counselling procedure and after submitting the online Preferences, the candidates must take out the print of it and ensure that the payment of Rs. 1000/- must be reflected in the payment column.
4. The Board shall provisionally allow all such candidates to participate in the online counseling process, who have failed to upload any of the documents viz. Domicile Certificate, 10th Class Marks Card, 12th Class Marks Card/Diploma for the purpose of ascertaining the D.O.B etc. with the condition that they must fulfill all the eligibility conditions as mentioned in the Notification No. 051-BOPEE of 2026 dated 14.04.2026 and have to submit all such documents at the time of their admission in the respective college, if selected.
5. It is further enjoined upon all the concerned candidates to ensure the validity of the Category Certificate, which in any case should not have been issued after **01-05-2026** i.e. the last date fixed by the Board for filling up of online application form for the GNM/ANM Courses, 2026.
6. The seats shall be allotted to the candidates as per **S.O. 176 dated 15-03-2024 read with S.O. 305 dated 21-05-2024** issued by Social Welfare Department, UT of J&K.
7. Seat Matrix shall be uploaded on website of the Board a day before the start of Counselling.
8. Regarding **fee structure** of the courses, participating candidates are advised to confirm it from the respective College/Institute where they intend to seek admission before applying for online process.

9. Mere filling up of the online Preferences/ Choices shall not confer any preferential right/claim upon the concerned candidate for admission to any course/college which shall further be subjected to eligibility to be verified at the time of admission, if selected, by the respective College/Institution.
10. The admission of the candidates is purely provisional and shall be liable to be cancelled in case of any information provided by any candidate is proved to be false/fabricated/untrue at any stage. The Board reserves the right to cancel the same and also take penal action as per relevant rules against the concerned candidate(s).
11. The candidature of any such candidate who found ineligible at any stage of admission shall be cancelled without any further notice.
12. The other Terms and Conditions shall remain the same as notified by the Board through the e-Information Brochure, Notifications & Notices issued from time to time in this regard.
