Subject: Conduct of second round of counselling for submission of online Preferences by the eligible candidates for admission to B-Pharmacy/D-Pharmacy Courses-2026.

Pursuant to Notification No. 109-BOPEE of 2026 dated 15.07-2026, the Board has received the shortfall of seats in B-Pharmacy/D-Pharmacy from various Government/private Colleges/Institutions of UT of J&K. In order to fill up the seats that have become available due to non-joining, resignation/surrender or which remained vacant during first round of counselling, it is hereby notified for the information of all concerned candidates that the Board shall conduct the second round of online counselling for admission to B-Pharmacy/D-Pharmacy Courses-2026 w.e.f. 27.07.2026(11:30 a:m) to 31.07.2026(Midnight).

The candidates are hereby informed that the allotment of seats shall be made strictly in accordance with the merit/score secured by the candidates, as reflected in the Provisional Merit List (PML) issued by Board vide Notification No. 089-BOPEE of 2026 dated: 28.06.2026. The Board shall in no case be responsible if a seat is allotted to any candidate based on the incorrect category mentioned in the online application form.

The following candidates shall be eligible to participate in the Second Round of Online Counselling:

- i) Candidates who were not allotted any seat during the first round of counselling.
- ii) Candidates who were allotted a seat during the first round and have joined the Institution.
- iii) Candidate who was allotted a seat in a particular institution during Round-1 of counselling and has either joined the allotted seat or failed to join, or cancelled/surrendered his/her admission after joining, shall not be permitted to opt for the same institution in this round. However, such candidate may opt for other institutions in this round, subject to the availability of a seat.
- iv) Candidates who have qualified the B/D Pharmacy Courses Common Entrance Test (CET)-2026 and have not participated in first round of Counselling

Note:

1. The online filling up of choices/preferences shall be available w.e.f. 27.07.2026(11:30AM) to 31.07.2026 (Midnight).The instructions regarding the filling up of online Choices/Preferences have already been notified in the Counselling Procedure, which is available on the official website of the Board (www.jkbopee.gov.in).
2. The candidates, who do not participate in the process of counselling by not filling up of the fresh preference forms, shall in no case be considered for allotment of seat in this round. They shall have no claim, whatsoever, on any seat filled up by the Board from amongst the candidates, who participate in the process.
3. The preferences indicated by the candidates during the first round of counselling shall be deemed to be cancelled and shall not be applicable for 2nd round of counselling. The candidates have to submit fresh preferences for 2nd round of counselling. If a candidate does not submit fresh choices/preferences during choice filling period, the candidate will not be considered for allotment of seat during 2nd round and will retain the already joined seat, if any.
4. In this round, only vacant seats shall be filled from respective categories as from where shortfall has been received i.e. the seats left-out by the OM candidates during the 1st round shall be allotted to the OM candidates and those left by the category candidates shall be allotted to the category candidates on the basis of merit-cum-preferences. The seats vacated by the candidate upon upgradation in this round shall be filled up simultaneously.
5. Candidates must consider available seats thoroughly and opt for such seats for which they are interested because Seat once allotted cannot be changed.
6. The candidates who have paid the online counselling fee during the 1st Round shall not be required to pay any fee during this round of counselling.
7. Seat matrix shall be uploaded separately and all the participating/eligible candidates are advised to go through seat matrix before participating in the counselling process.The Seat Matrix shall be made available/uploaded on the official website of the Board one day prior to the commencement of counselling i.e.on 26.07.2026.
8. The candidature of any candidate who is found ineligible at any stage of admission shall be cancelled without any further notice.
9. The other Terms and Conditions shall remain the same as notified by the Board through the e-Information Brochure, Notifications & Notices from time to time in this regard.
