IMPORTANT NOTES

1. No candidate shall be permitted to surrender the allotted seat after the prescribed date and time, i.e. 07.08.2026 up to 02:00 PM.
2. Candidates are advised to give preferences for all available colleges, categories and quotas, as seats may become vacant due to shifting/upgradation of candidates during the online allotment process.
3. Vacant seats of reserved categories shall be converted to Open Merit, as per the applicable rules, after completion of the 2nd Round of online Counseling for the respective reserved categories.
4. The seats shall be allocated in the following order of priority:
 - i) PPBNET-2026 qualified candidates belonging to Punjab State.
 - ii) PPBNET-2026 candidates belonging to Punjab State who have appeared in PPBNET-2026 but have not qualified.
 - iii) Punjab State candidates seeking admission on the basis of the qualifying examination, i.e. GNM.
 - iv) PPBNET-2026 qualified candidates belonging to States/Union Territories other than Punjab.
 - v) PPBNET-2026 candidates belonging to States/Union Territories other than Punjab who have appeared in PPBNET-2026 but have not qualified.
 - vi) Candidates belonging to States/Union Territories other than Punjab seeking admission on the basis of the qualifying examination, i.e. GNM.
