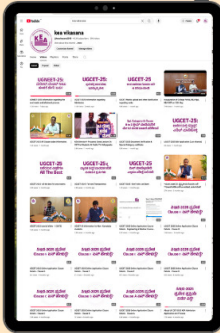

## 1. INTRODUCTION:

Government in their letter No.; **HFW 124 RGU Bangalore, dated 28-06-2017**, has directed KEA to conduct Common Counseling for admission to UG Medical and Dental courses for all Government, Private (Including Minority), NRI and Others seats in the State of Karnataka. As per MCI Medical Education Regulations, 2000 as amended from time to time and Government order No. HFW 320 RGU 2016, Bangalore dated 13-04-2017, and as per the decisions of the Entrance Test Committee, Karnataka Examinations Authority (KEA) is inviting applications online from the eligible candidates who have qualified in UGNEET 2026, for admission to Medical / Dental courses in Government Medical and Dental colleges, Government Quota seats in Private and Minority Medical and Dental Colleges and all seats in Private Medical and Dental colleges (KPCF, KRLMPCA, AMPCK) located in the State of Karnataka for the academic year 2026-27.

**1.1.** As per the letter dated **13-07-2023 of Karnataka AYUSH Department**, 85% of seats available for admission in Government and Government Aided Institutions (except 15% All India Quota) and in Private Institutions all seats (including State Quota, All India Quota and Management / NRI quota) available for UG courses in Private Ayurveda, Unani and Homeopathy Colleges of Karnataka state shall be allotted through KEA. **All the UG NEET qualified candidates are hereby advised to register online and complete the document verification process in KEA to become eligible for admission to UG AYUSH Courses in the State of Karnataka.** However, non-Karnataka candidates are eligible only for the notified seats.

**1.2.** Centralized Counseling for the seats to be notified by the Karnataka State Government, in Government, KPCF, KRLMPCA, AMPCK institutions, the admissions will be as per the Karnataka Selection of Candidates for Admission to Government Seats in Professional Educational Institutions Rules, 2006 (in short Rules) as amended from time to time and as per the guidelines of MCI / DCI / Ministry of Health and Family Welfare/ Government of India / Medical Education, Karnataka / Director Medical Education, Karnataka / Entrance Test Committee.

**1.3.** The Information Bulletin for UG NEET 2026 for examination for admission to Medical and Dental Courses for the academic session 2026-27 for All India seats & State Government Quota seats have been published by the Central Board of Secondary Education. This additional bulletin is in continuation for the State of Karnataka for verification of Documents and Online Seat Allotment for centralized counseling.

- 1.4.** As per NMC, New Delhi letter dated 24-07-2023; all the rounds of counseling including Stray Vacancy Round will be conducted only by KEA in online mode, all the UG NEET qualified candidates are hereby advised to register online and complete the document verification process in KEA to become eligible for admission to UG Medical and Dental Courses in the State of Karnataka.
- 1.5.** A candidate who had obtained a Medical / Dental / Ayurveda / Homoeopathy / Unani seat in any of the previous years and not surrendered the seat before the last date fixed for entry of options for final round of seat allotment and candidates already studying Medical / Dental / Ayurveda / Homoeopathy / Unani will not be eligible for allotment of a Medical / Dental / Ayurveda / Homoeopathy / Unani seat during 2026.
- 1.6.** If the information furnished by the candidates in the application form or any other document/s submitted by the candidates / parents are found to be false / incorrect / tampered / forged such candidate's seat will be cancelled at any point of time during his / her course of study and proceedings as per rules will be initiated by KEA against the candidate.
- 1.7.** Candidates who do not pass in all the subjects in the qualifying examination and candidate, who do not possess the required academic eligibility, will not be eligible to be considered for verification of documents and also for allotment of Medical and Dental seats.
- 1.8.** The SC / ST/Category-I / 2A, 2B, 3A and 3B and other eligibility criteria is applicable to Karnataka candidates who are eligible to claim eligibility for Government seats under clauses (a), (b), (f), (h), (j), (k) (l) and (o) and the same is not applicable to eligibility clauses (c), (d), (e), (g), (i), (m) and (n) to claim Government Seats and Government quota seats. Reservation of seats in certain categories such as Rural, Kannada etc and in Special Categories such as NCC, Sports etc is applicable only to Karnataka candidates who are eligible for Government seats and Government Quota seats.
- 1.9.** Government vide its order number SaKaE 08 SLP 2024 Bangalore dated 25-08-2025 and DPAR 02 SeHiMa 2026 Bangalore dated 27-04-2026 has provided internal reservation for Scheduled Caste candidates as SCA, SCB and SCC. Therefore, the candidates who have not obtained the caste certificate with internal reservation details till now have been informed to immediately obtain the caste certificates with internal reservation printed and enter the RD number during the entry / linking of NEET roll number or before the last date / time prescribed for registration.

**1.10.** As per the Government Order No. ಸಿಆಸುಇ 02 ಸೇಹಿಮ 2026 ಬೆಂಗಳೂರು ದಿನಾಂಕ 27-04-2026, Internal reservation would be applicable to Scheduled Caste category candidates who have entered the RD Number containing internal reservation.

**1.11.** A candidate may have option to select Medical / Dental etc; seat in other boards. In case such candidate wishes to confirm the seat selected from other boards then such candidate who has also been allotted a seat through KEA has to surrender the seat allotted by KEA before the last date fixed for modifying of options of Second Round of seat allotment, failing which it may amount to blocking of seat and KEA may initiate action / proceedings against such candidates.

**1.12.** If a candidate decides to surrender the seat, he / she have to surrender the seat only to KEA in writing. Merely not reporting to the selected / allotted college should not be presumed by the candidate that he / she have surrendered the seat to KEA.

**1.13.** Please read the refund and forfeiture conditions detailed in this brochure carefully.

**1.14.** No requests for mutual transfer of seats will be entertained by KEA at any point of time.

**1.15. APPEAL:**

Any person aggrieved by the order or decision of the Executive Director under CET-2006 Rules may within 15 days from the date of such order or decision, appeal to the Additional Chief Secretary to Government, Education Department (Higher Education), / Medical Education, Government of Karnataka, who after calling for records from the Executive Director and after examining the same, shall pass orders as he deems fit, which shall be final.

**1.16 LEGAL JURISDICTION:**

Any dispute that may arise in respect of the test or the later seat selection process, admission, fees and cancellation is subject to the jurisdiction of the Hon'ble High court of Karnataka. The issuance of admission order by the KEA shall enable the candidate to join the concerned college, subject to the academic eligibility, etc., being approved by the concerned University as per the Regulations.

## **2. COMPULSORY RURAL SERVICE FOR ONE YEAR:**

All candidates who take admission to Medical course shall undergo one year compulsory rural service in Government hospital as per Karnataka Compulsory Service Training by Candidates Completed Medical Courses, Act 2012 as amended in 27/09/2017 and Karnataka Compulsory Service by Candidates Completed Medical courses (Counseling, Allotment and Certification) (Amendment) Rules, 2017. Please note that candidates will be entitled to only temporary registration till completion of such service. Until they complete the same, they will not be entitled for permanent registration. **All the candidates who will be allotted Medical Seats through KEA both in Government and Private Medical colleges** should compulsorily submit sworn affidavit to the Principal of the respective college at the time of admission (on a hundred Rupees e-stamp paper signed by the candidate and the parent as per the format hosted on the KEA Website) regarding one year rural service after completion of the course.

## **3. ONLINE REGISTRATION TO MBBS / BDS / AYUSH COURSES**

- 3.1** The candidates who have qualified in UGNEET – 2026, eligible and interested, have to compulsorily register online in the LINK provided on the KEA Website and to produce the relevant documents for verification to become eligible for admission to Medical and Dental and AYUSH courses 2026-27.
- 3.2** Candidates are neither required to send any certificates / documents in support of their eligibility nor printout of their Application Form (Final Printout) to KEA during or after the completion of registration.
- 3.3** However the candidates, in their own interest, must satisfy themselves about their eligibility for the Test / admission to relevant courses. In the event of any ineligibility being detected by the Government / KEA / University / Apex Body at any stage, their candidature will be cancelled and they shall be liable for legal action.
- 3.4** As per NMC, New Delhi letter dated 24-07-2023; all the rounds of counseling including Stray Vacancy Round will be conducted only by KEA in online mode, all the UG NEET qualified candidates are hereby advised to register online and complete the document verification process in KEA to become eligible for admission to UG Medical and Dental Courses in the State of Karnataka.

\*The SC / ST/Category-I / OBC eligibility criteria is applicable to Karnataka candidates who are eligible to claim Government seats under clauses (a), (b), (f), (h), (j), (k), (l) and (o) and the same is not applicable to clauses (c), (d), (e), (g), (i), (m) and (n) i.e., Eligibility Clauses to claim Government Seats.

#### NOTE

The details and instructions contained in this Information Booklet is in continuation of the earlier information bulletin released for admission to UGCET-2026 courses; and any kind of guidelines or procedures or notifications issued by KEA or conduct of verification process or seat allotment are subject to Hon'ble Courts directions / Admission Rules / Government orders issued from time to time. In case of any discrepancy, the Rules shall prevail and the decision of NMC / MCC / DCI /Government / Competent Authority / Universities / Karnataka Examinations Authority / Entrance test committee shall be final.

#### ONE TIME OPTION ENTRY:

The options entered by the candidate for the first round will remain same for the second round of seat allotment. The candidates will not be allowed to enter options again. Option Entry done before the first round will be the final list of options. The priority of options entered by the candidate will be shown on the option entry module by obtaining the candidate credentials in the subsequent round. Candidate may delete or alter order of higher options. The candidate will be allowed to add new options for any colleges and course that is added to the seat matrix after the first round.

#### 4. WHEN CAN A CANDIDATE REGISTER? (ONLINE REGISTRATION PROVISIONS)

As per the directions of the Government, KEA will invite the applications through online registration from candidates who have qualified in UGNEET-2026 and fulfill the eligibility criteria for admissions to Medical and Dental and AYUSH courses for the year 2026-27. The candidates who have scored more than or equal to the prescribed minimum score in UGNEET-2026 only are eligible to register and apply online for UG Medical and Dental and Ayurveda, Unani and Homeopathy degree courses for the year 2026-27. [Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only].

##### CANDIDATES WHO HAVE NOT REGISTERED FOR CET-2026 - PROCEDURE

- 4..1 Candidates who have not registered for UGCET-2026 have to register through online and submit application and pay the fees to become eligible for admission to Medical, Dental and AYUSH courses by selecting “UGNEET-2026 new registration” as per the schedule.
- 4..2 Candidates who have registered for CET-2026 will be given a link on the KEA Website shortly to add their NEET roll number to the CET 2026 application; no fresh registration is required.

- 4.3 The minimum qualifying marks prescribed by the competent authority after the publication of results of UGNEET 2026 re-examination for admission to Medical, Dental, AYUSH courses will be applicable. Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.
- 4.4 The category of candidates who will have to appear for document verification will be notified later. The educational qualifications and such other criteria will be published on the KEA Website for the information of the candidates. Before registering through online for admission to Medical and Dental courses in the state of Karnataka, applicants are hereby informed to read the Information Bulletin UGNEET-2026 and understand the eligibility conditions, classification of seats (different types of category of seats) and eligibility to claim such seats.

##### INSTRUCTIONS TO NON-KARNATAKA CANDIDATES

Non-Karnataka candidates have to first register through online in KEA Web-portal (if not registered earlier in KEA), enter all the details, and pay the registration fee. Further they have to enter the 12<sup>th</sup> standard marks details and upload in PDF format in the Marks Entry web portal. They need not appear for verification of documents.

However, OCI / PIO / NRI / Foreign Nationals and if any non-Karnataka candidates eligible to claim NRI Ward, Religious Minority or eligible to claim under Category-RC-2 to Category-RC-8 in St. John Medical College, Bangalore, then they have to appear for verification of documents at KEA, Bangalore by booking the slots to appear for verification.

### Downloading of Verification Slip and Information on Verification

1. After entry of UGNEET Roll Number download the application form. Candidates should verify the UGNEET Roll Number printed in the UGNEET-2026 Application Form.
2. Then download the “UG Verification Slip” from KEA Website. Since verification is completed through online, verification of documents is not required again.

### NRI Ward verification

(only for candidates who have already claimed in the UGCET-2026 application)

Candidates who have claimed NRI Ward in the UGCET-2026 application form, should first enter the UGNEET Roll Number, download the application form and then appear for physical verification with all the necessary original documents (along with two sets of Xerox) at KEA, Malleswaram, Bangalore by booking the slot.

### St. John Medical College, B'lore (Category-RC-2 to Category-RC-8) Reservation Verification

In the UGCET-2026 application, candidates who have claimed Category-2 to Category-8 in St. Johns Medical College, Bangalore, should appear for verification of documents in person at “Medical College Council Room, Ground floor, St. John's Medical College, Koramangala, Bengaluru” with all the relevant original documents (Category-RC-1 and Category-RC-9 of St. John Medical College, Bangalore **need not** appear for verification)

- i. Eligibility and other conditions of St. Johns Medical College, Bangalore is hosted on the KEA Website.
- ii. Regarding ESIC bond condition and format, visit KEA Website.
- iii. Rural Service Bond format is hosted on the KEA Website.

## 4.5 KARNATAKA CANDIDATES:

UGNEET-2026 qualified Karnataka Candidates (i.e. candidates claimed Clause A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, Z in their online application) who have registered and filled the online application from 17-07-2026 onwards, should appear in person with all the original relevant certificates as per the following schedule to become eligible for admission to Medical / Dental / AYURVEDA, UNANI, HOMEOPATHY courses. Original documents to be submitted for verification are already hosted in the KEA website at the time of UGCET itself. Kindly refer the same.

**4.6 “Non-Karnataka candidates” i.e. purely Clause-Y, need NOT appear for verification, they have to download the verification slip on the notified dates.**

However, if any non-Karnataka candidate claimed “Z”, OCI/ PIO / NRI / Foreign Nationals, NRI Ward, Religious Minority or eligible to claim seat under Category-2 to Category-8 in St. John Medical College, Bangalore, then they have to appear for verification of documents with all the original necessary documents as per the above schedule. (*Category-1 and Category-9 of St. John Medical College, Bangalore need not appear for verification*)

**4.7** Candidates, who have assigned ranks in UGCET-2026 and completed their document verification as per CET-2006 Admission Rules, need not appear for verification of documents once again for Medical / Dental / AYURVEDA, UNANI, HOMEOPATHY courses. But they have to download the UGNEET-2026 Verification slip from KEA portal on the specified dates to become eligible for admission to Medical / Dental courses.

**4.8 INSTRUCTIONS FOR NON-KARNATAKA CANDIDATES**

Non-Karnataka candidates are not eligible for reservation. Hence, in the UG NEET 2026 examination, if they have scored the required minimum marks or above fixed for others category as per the qualifying criteria i.e., 50th Percentile, then only they are eligible to register for admissions through KEA or for any other seats in the state of Karnataka. Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.

Non-Karnataka candidates who have qualified in UGNEET 2026, they have to first register through online at KEA Web-portal, enter all the details, and pay the registration fee. Further they have to enter the 12<sup>th</sup> standard marks details and upload in PDF\* format in the same web portal. They need NOT appear for verification of documents.

**PDF\* - Steps:**

1. Enter the 12<sup>th</sup> standard marks details in the portal.
2. Candidates have to upload the UGNEET-2026 Score Card, 10<sup>th</sup> Marks card and 12<sup>th</sup> Marks card as a single PDF.
3. Scan in one single file UGNEET-2026 Score Card, 10<sup>th</sup> Marks card and 12<sup>th</sup> Marks card and upload as one single PDF.

However, OCI/ PIO / NRI / Foreign Nationals and if any non-Karnataka candidates eligible to claim NRI Ward, Religious Minority or eligible to claim seat under Category-2 to Category-8 in St. John Medical College, Bangalore, then they have to appear for verification of documents with all the original necessary documents on the specified dates.

**4.9 Verifications of documents -Instructions continued**

**4.9.1** KEA is entrusted with document verification for determining the eligibility of the candidates as per the directions of the Government and the allocation of seats as per the online seat Allotment and Admission Procedure. The results of UGNEET-2026 published by NTA, New Delhi will be taken into consideration for preparation of rank list after verification of original documents and allotment of seats to all eligible candidates for UG Medical & Dental seats.

- 4.9.2** The SC / ST/ OBC eligibility criteria is applicable to Karnataka candidates who are eligible to claim eligibility for Government seats under clauses (a), (b), (f), (h), (j), (k) (l) and (o) and the same is not applicable to eligibility clauses (c), (d), (e), (g), (i), (m) and (n).
- 4.9.3** The candidates who have qualified in UGNEET-2026 Examination will have to get their original documents verified to become eligible for Option Entry for choice of allotment of Medical / Dental seat as per the instructions / guidelines.
- 4.9.4** Verification of documents will be done as per the schedule notified later. The candidate should confirm the rank ranges, date and time of verification before coming to KEA, Bangalore. No individual intimation will be sent to the eligible rank holders regarding the date and time of verification process. The original documents to be produced during verification have been detailed for different categories of seats. Candidates who seek admission should compulsorily produce and carry the prescribed documents in ORIGINAL with ONE set of attested photocopies of all the original documents as per their eligibility.
- 4.9.5** The candidate should compulsorily bring all necessary original documents in support of their claim when they come for verification without fail.
- 4.9.6** If any candidate fails to produce any of the documents / certificates / marks card on the day of verification, such candidate's documents will not be verified and they will not complete their registration process and subsequently will not be considered for eligibility to exercise their options.
- 4.9.7** After Registration, the candidates will proceed to the Verification Counter where the entries of original documents are verified against the computer data that would have been furnished by them in their application forms. After verification, the original documents will be returned to the candidate and KEA will retain one set of the attested photocopies of all the documents. Before leaving the verification counter, an acknowledgment cum verification slip will be issued to the candidates.
- 4.9.8** Verification of documents is common for both Medical and Dental disciplines together. Verification slip will be issued to all the eligible candidates. It will contain the details of the candidates, documents verified, caste category and merit / rank to which discipline he / she is eligible etc. will also be printed on the slip. The candidate before leaving the verification counter has to verify all the details printed on the verification slip and changes if any according to the documents he / she submitted, should be brought to the notice of the verification officer immediately.

**NOTE:** No changes / claims will be accepted once the documents are verified and verification slip is issued to the candidate for any reason. ## 11.CLASSIFICATION OF SEATS

Only UG NEET 2026 qualified candidates who become eligible after verification of documents submitted by the candidates, are allowed to participate in the allotment of Medical / Dental seats as per the eligibility & reservation criteria for the respective types of seats which is detailed in the subsequent pages.

These seats are classified into four categories namely;

1. **G** - Government Seats
2. **P** - Private Seats
3. **N** - NRI Seats
4. **Q** - Others Seats

### 11.1. (G): GOVERNMENT SEATS,

Means and includes seats in Government colleges and Government share of seats in Private colleges.

- a) **100%** of Seats in Government colleges
- b) **40%** of Seats in case of Medical and **35%** in case of Dental in Private Non-Minority colleges (KPCF)
- c) **25%** of Seats in both medical & dental Private Minority (Religious & Linguistic) colleges.

### 11.2. (P): PRIVATE SEATS,

Means seats in Private Colleges (KPCF, AMPCK, and KRLMPCA)

In KPCF Colleges: 40% seats in case of Medical and 45% in the case of Dental seats reserved as private quota seats.

- a) **\*GMP seats:** For 50% of the above 40% or 45% seats as the case may be, only Karnataka candidates are eligible (referred as **GMP** seats / **GMP** with Hyd-Kar seats in case of colleges located in Hyd-Kar region).
- b) **OPN seats:** Remaining 50% of the above 40% or 45% seats as the case may be are "OPEN" quota seats: These seats are filled based on NEET UG All India merit and only Citizens of India are eligible.

**In KRLMPCA and AMPCK Colleges; - 55% of seats reserved as private quota seats.**

- a) **66%** of the above seats will be filled by respective religious /linguistic minority candidates (MK, MA, ME, MU, MC, MM seats).
- b) In **34%** of the above seats
  - a) **\*GMP:** 50% of the above **34%** seats are reserved for candidate of Karnataka Candidates (GMP seats).
  - b) **OPN:** 50% of the above **34%** seats are reserved for All India candidates who are Citizen of India (OPN seats).

**\*Karnataka Candidates and who are claiming eligibility for Government seats under clauses (a),(b), (f), (h), (j), (k), (l) and (o) are only eligible for GMP seats.**

### 11.3. (N): NRI SEATS

Means **15%** of the total seats reserved for NRI quota in KPCF, KRLMPCA and AMPCK colleges.

### 11.4. (Q): OTHER SEATS

Means **5%** of the total seats reserved for others in KPCF, KRLMPCA & AMPCK colleges.

## 12. ELIGIBILITY FOR GOVERNMENT SEATS (G):

- (a) The candidate should fulfill the academic eligibility criteria as given above and has qualified in the UGNEET 2026 (National Eligibility cum Entrance Test).
- (b) The candidates who fulfill the eligibility criteria in accordance with the Karnataka Selection of Candidates for Admission to Government Seats in Professional Educational Institutions Rules, 2006 (in short Rules) as amended from time to time.
- (c) He / She is a citizen of India and satisfies any one of the following conditions: -
- (d) The candidates who do not satisfy any of the Clauses / Eligibility Criteria detailed below and the candidates who do not produce the prescribed documents in original will not be eligible for admission to professional courses under Government quota seats.
- (e) Other than the certificate mentioned in clauses, if a candidate claiming seat under Article 371 (j) Hyderabad-Karnataka region reservation, candidate should produce eligibility certificate from the concerned Assistant Commissioner as per the format in Annexure and if a candidate is claiming;
- (f) NRI Ward, Ward Certificate should be submitted. (ANNEXURE-6)
- (g) Each condition is specified as a clause and is individually referred by a code. The relevant documents to be produced for verification of documents in support of the claim for each of the Clauses are also detailed below the respective clauses.

The candidate should have studied and passed in one or more Government or Government recognised educational institutions located in the State of Karnataka for a minimum period of SEVEN academic years commencing from 1st standard to 2nd PUC / 12th standard as on 1st July of the year in which the Entrance Test is held and must have appeared and passed either SSLC / 10th standard or 2nd PUC / 12th standard examination from Karnataka State. In case of the candidate who had taken more than one year to pass a class or standard, the years of academic study is counted as one year only.

- 3) Candidate's Study Certificate; Candidate's STUDY CERTIFICATE obtained from the head of the institution which should be countersigned by concerned Block Educational Officer (BEO) / DDPU (7 years of study in Karnataka including 10th or 12th) (Refer formats in the following pages)
- 4) Rural Study Certificate from 1st to 10th std for Ten Complete Years and should be countersigned by BEO. Further, General Merit students should also produce NCLC obtained from the concerned Tahasildar. (Refer formats in the following pages)
- 5) If claiming Kannada Medium quota: Kannada Medium Study Certificate from 1st to 10th std for Ten Complete Years and should be countersigned by BEO; as per the format.
- 6) If claiming reservation benefits: Caste / Caste Income Certificate issued by Concerned Tahsildar- For SC / ST in Form-'D', Category-I in Form 'E' and 2A, 2B, 3A and 3B in Form 'F'. Caste Certificate or Caste Income Certificate or Income Certificate should be in the name of the candidate only. Income certificate to be produced by SC / ST / Cat-1 to claim fee exemption.

(C) 891/2021, OCI/PIO candidates- Clause a1 (In case of 7 years of study in Karnataka including 10<sup>th</sup> or 12<sup>th</sup> - they will be treated at par with Indian Citizens and will be eligible for General Category seats – not entitled to claim any reservation)

Caste Certificate or Caste Income Certificate or Income Certificate should be in the name of the candidate only.
- 6) If claimed NRI Ward, Ward Certificate should be submitted. (ANNEXURE-6)

**Clause-b1**

In pursuance of the orders of the Hon'ble Supreme Court in W.P. (C) 891/2021, OCI/PIO candidates- Clause b1 (In case of, the candidate should have studied and passed either 1st and 2nd year Pre-University Examination or 11th and 12th standard examination within the State of Karnataka from an Educational Institution run or recognized by the State Government and that either of the parents should have studied in Karnataka for a minimum period of SEVEN years-they will be treated at par with Indian Citizens and will be eligible for General Category seats – not entitled to claim any reservation.

- 5) Candidate's Study certificate, Transfer Certificate, with mother tongue details.
- 6) Father / Mother 10th standard marks card / cumulative record in original in support of mother tongue as Kannada / Tulu / Kodava / Beary.
- 7) A duly sworn declaration regarding mother tongue of the candidates.
- 8) If claimed NRI Ward, Ward Certificate should be submitted. (ANNEXURE-6)

**Clause d**

A candidate whose mother tongue is Kannada, Tulu, Kodava or Beary should have resided and studied for a period of SEVEN YEARS between 1st and 12th standards in disputed Kannada speaking area of South Sholapur or Akkalkot or Jath or Gadhinglaj Taluks of Maharashtra State or Kasargod or Hosadurga or Manjeshwar Taluks of Kerala State. Provided that the candidate shall undergo a Kannada Language test conducted by KEA.

- 2) 2nd PUC / 12th standard Marks Card of the candidate, along with
- 3) Residential certificate from the concerned Tahsildar of the respective disputed Taluk.
- 4) Candidate's study certificate issued by the head of institution, which should be countersigned by Taluk Education Officer, with mother tongue details.
- 5) Candidate / Father / Mother 10th standard marks card / cumulative record in original in support of mother tongue as Kannada / Tulu / Kodava / Beary.
- 6) A duly sworn declaration regarding mother tongue of the candidate.
- 7) If claimed NRI Ward, Ward Certificate should be submitted. (ANNEXURE-6)

**Clause e**

In the case of a candidate who is son or daughter of defense personnel who has worked continuously in Karnataka for a minimum period of one year in Karnataka during the Two year period of study of candidates in PUC / 11th and 12th Standard course. The candidate should have studied and passed the qualifying examination from any Government or Government recognised educational institution located in the State of Karnataka.

- 2) 2nd PUC / 12th standard Marks Card of the candidate, along with –

- 16.3.** In case of any discrepancy in the verification slip, please contact KEA to check the documents and application by booking a slot. (Before the first round of seat allotment starts)
- 16.4.** In case of any discrepancy found and if a candidate fails to bring it to the notice of KEA, the candidate shall be solely responsible for any consequences arising there from.
- 16.5.** The courses offered by each college, course wise the number of seats available, and the distribution of reserved seats, as issued by the Government to KEA- these consolidated information, known as the *seat matrix*, will be published on the KEA Website.
- 16.6.** Likewise; the Government will issue an order by prescribing the fees for all the courses. The candidate should compulsorily take note of the fees before choosing the colleges/courses.
- 16.7.** The schedule will be published on the KEA Website before starting the seat allotment for various rounds.

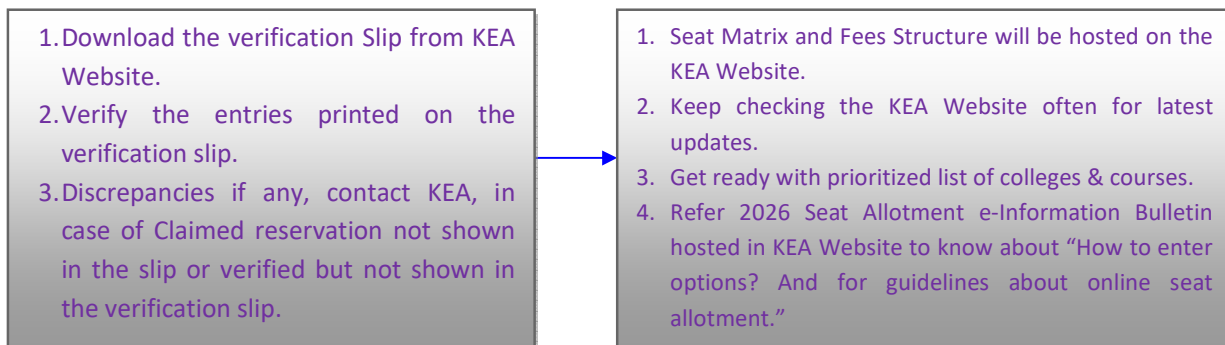
## 17. FLOW CHART – ONLINE SEAT ALLOTMENT STAGES

### A. FIRST ROUND SEAT ALLOTMENT

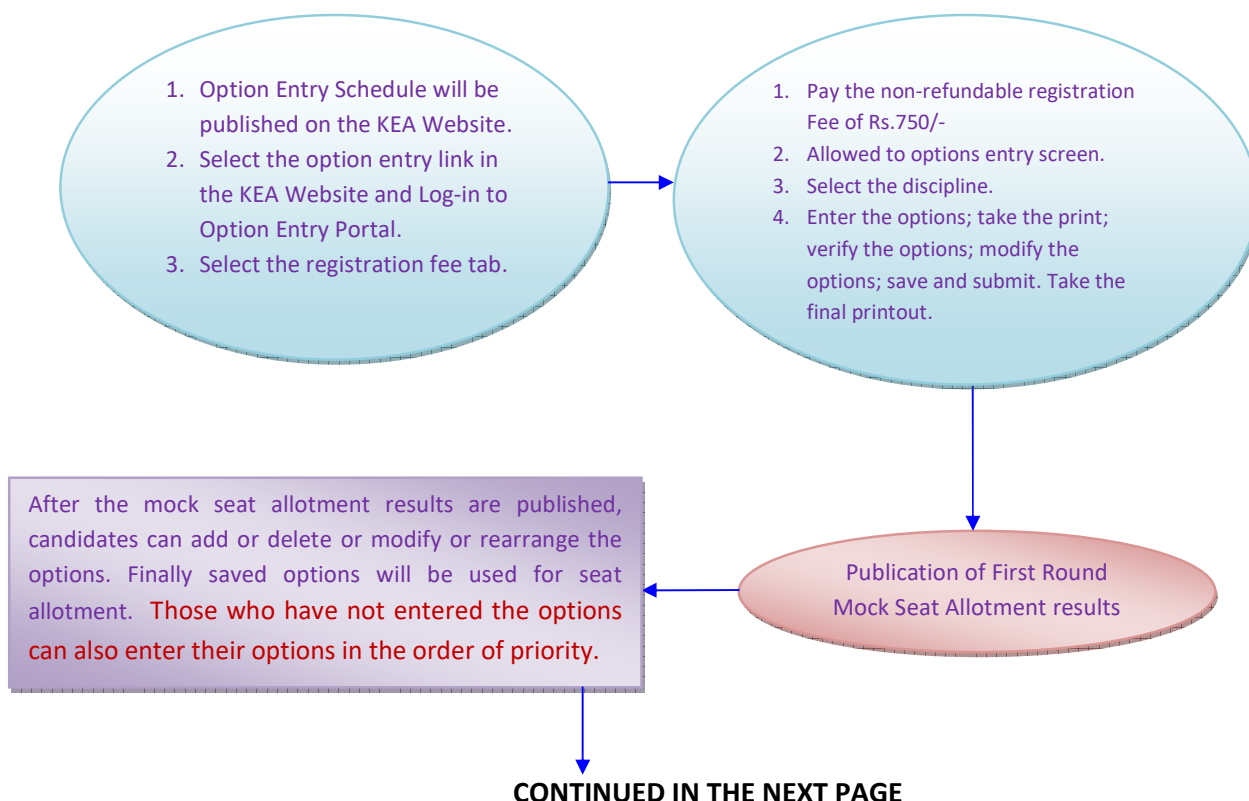

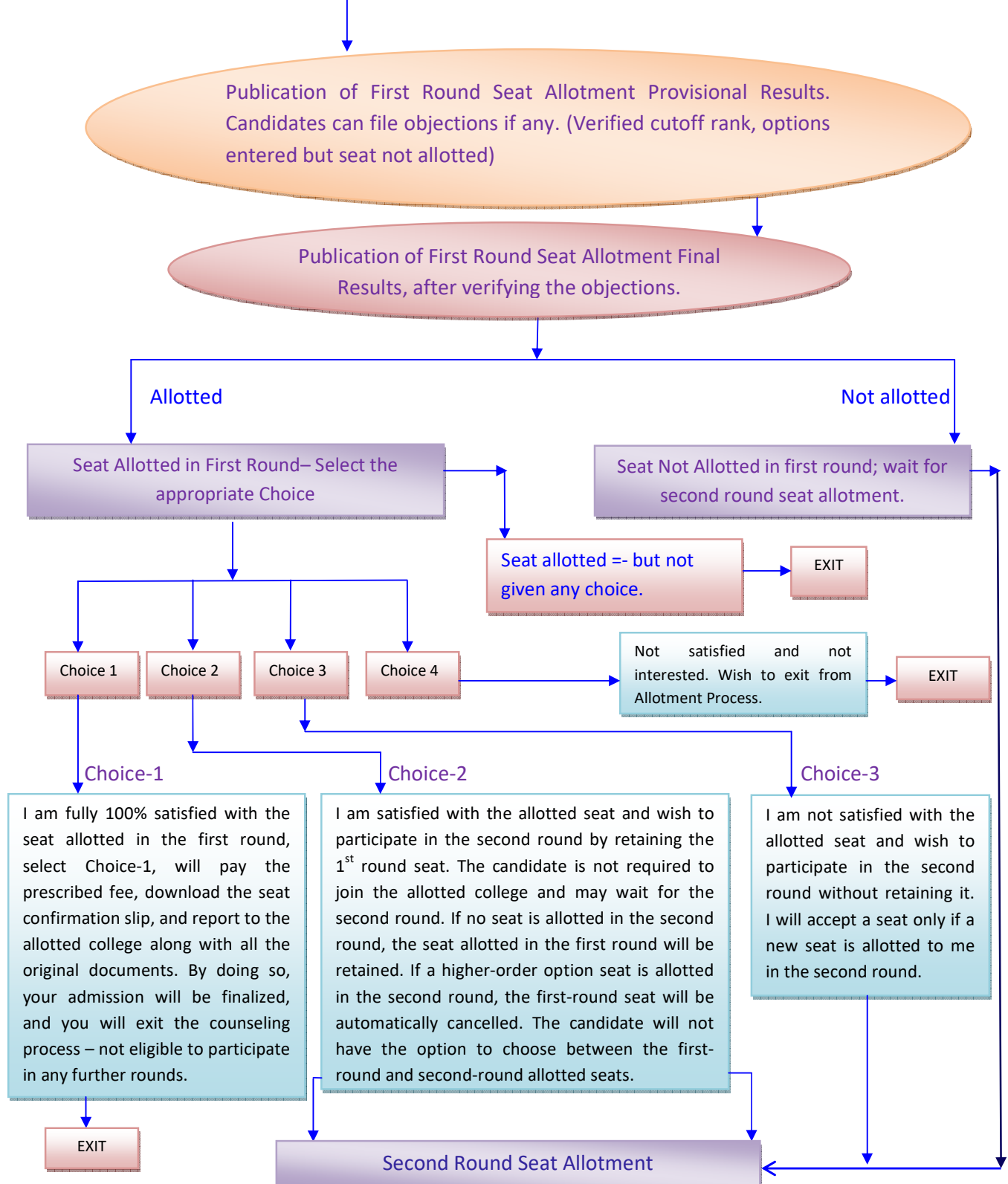

If any candidate fails to report to the college after allotment of seats in the 3<sup>rd</sup> Round / Casual Vacancy, legal action will be initiated against such candidate in accordance with law.

## 18. OPTIONS ENTRY BY CANDIDATES

- 18.1 Entry of options by the candidates will begin only after seat matrix notified by the Government. The details of the College wise, Course wise and Category wise seats available for allotment will be published on the KEA website which can be downloaded and printed.
- 18.2 The candidate who becomes eligible after verification will only be considered for entry of options. The candidate may enter the course / college of his choice from among the seats available which is displayed at the time of entry of options i.e., college wise, category wise and course wise. **The candidate will be allowed to enter all the options only if he/she is eligible after document verification.** Candidate shall enter the options for both the discipline (Medical and Dental) at once. Upon entry of preliminary information by the candidate on the internet at the specified URL, the option entry form will be displayed. (Candidate has to enter his secret key and valid Password.)
- 18.3 The candidate has to first select the discipline in the option entry form. Upon selection of a Medical discipline, the entry form displays the list of Medical colleges and Dental colleges in case of selection of Dental discipline. The candidate has to enter the priority number in front of the displayed college to which they are eligible and interested. That means, first option may be Medical, second option may also be Medical, third option may be Dental, fourth one may be again Medical, fifth option can be Dental, the sixth may be Medical again and so on.
- 18.4 **There is no limit for entry of options.** A candidate can enter any number of options as he / she wishes to exercise on his / her own priority. Candidates are advised to enter more number of options to avoid the disappointment of not securing a seat. Any candidate has to enter the option in the priority as he / she desires. Candidates are advised to do thorough home assignment regarding the choices which they want to exercise, the college which they prefer, the course which they are interested to join etc. It is better to write the order of options on a sheet of white paper and discuss the same with your parents / guardians / mentors etc before actually entering same in the system. Your interest in the discipline, college infrastructure, course, distance from your place, availability of hostel etc may be some of the issues to guide your choices of options and advice of your parents. As it will save your time and minimize your chance of making mistake in option entry on the online option entry form. **A candidate can enter any number of options online after login, of his choice of College / Colleges and courses in the order of the choice he / she desires.** The allotment will not proceed to the next rank candidate till the list of your options is completely searched for availability of a seat. The

candidate may change the options as many times as he / she desires before the last date and time notified for entry of options. After entry of options candidate submit and logout.

18.5 Options recorded in the server on the last day and time of the notified schedule in that round will be frozen and only the frozen options will be considered for allotment of seats. The candidates are advised to take a print out of the option entered by them in each round after the last date and time for entry of options is over. The options entered by the candidate for the first round will remain same for the subsequent round of seat allotment. The candidates will not be allowed to enter options again. Option Entry done before the first round will be the final list of options.

18.6 Please enter URL or Website address <https://cetonline.karnataka.gov.in/kea/ugneet2026> or as indicated in the notification. Upon entry of URL you will find link like “UGNEET-2026–OPTION ENTRY” and select the links regarding the information on many items.

18.7 **ONE TIME OPTION ENTRY:**

The options entered by the candidate for the first round will remain same for the subsequent round of seat allotment. The candidates will not be allowed to enter options again. Option Entry done before the first round will be the final list of options. The priority of options entered by the candidate will be shown on the option entry module by obtaining the candidate credentials in the subsequent round. Candidate may delete or alter order of higher options. The candidate will be allowed to add new options for any colleges and course that is added to the seat matrix after the first round.

**Note:** Candidates should compulsorily register using User ID and Secret Key and execute the option entry. If the candidate has either not registered or registered but not executed option entry he/she will not be considered in further process of online seat allotment rounds.

**Preparatory work at home:**

Allotment of seats depends entirely on the **priority of options** given by the candidates as per the merit / rank. Hence it is of utmost importance to familiarize oneself with the operation of the computer, the locking of seats so that the correct choice and options are entered. Practice of entering of options has to be undertaken as even an expert in computers would require a minimum of half an hour for entry of about 100 options. Familiarity with the computer, prior knowledge of the college, course is essential to fill up options. Even a small mistake in entering the options may deprive a valuable seat in the desired college / course even though he / she is eligible for that seat as per his / her rank. Therefore, KEA suggests that the student should familiarize themselves in entering the options in the online option entry form. A home work of about an hour

everyday is necessary for the students to familiarize themselves with the allotment. The following steps may be taken by the candidates before entering their options in the online option entry form.

- The candidate should note the name of the college, the course offered in a separate sheet of paper.
- Preparatory work should be commenced only after asserting their merit / rank order.
- The priority of options among the colleges/courses selected should be noted down.
- A mock allotment on real time data given by the candidates will also be done before the actual commencement of the First-Round allotment, so that the candidate can know the college and course allotted as per his options. The candidate can also change his options after seeing the mock allotment. This will help him to find out his standing as per his merit and as per options. **The mock test is only to help the candidates familiarize and show them the course and college allotted to them and it should be in no way presumed that the same seat and college will be allotted to them in the actual allotment of seats.** Because, the candidates have the option of changing the priority of the options entered by them after the mock allotment.
- The verification Acknowledgement issued to the candidates indicates the category which he / she belongs, rank number he / she eligible, special category if any etc. It will help in choosing the college or course or place of the college.

The entire process of allotment is controlled by sophisticated software and high-end computers which examines minutely the options given by the candidates for allotment of the best possible seat to the candidate as per the rank and options given. Therefore, it is very important that the candidate should be very clear about the choice of the course, college and subject which he is interested in. For example, if a candidate is interested only in Medical seats then he can give all the options in all the colleges for allotment of Medical seats only. There may be about 38 Medical colleges and the candidates can give 38 options in all colleges if interested. The computer will decide the best seat available for allotment as per the rank and order of options of the candidate. Similarly, a candidate may be interested only in Dental and he may opt for Dental College as per his choice. The computer will pick up the best options available as per merit and order of options. In other words, the candidate is free to give as many options in as many courses in as many colleges as he deems fit. The more number of options the better it is for the candidate to secure a seat of his choice.

**NOTE: Candidates are advised not to start entering the options directly on the online option form on the internet without preparatory work at home on choice of options, as it leads to commission of mistakes / wrong entries / wrong order of preferences.**

**NOTE: Please ensure that whether you are entering the options for Medical or Dental course in the college of your choice before entering options. Confirm and then submit / save the entries.**

The candidates are advised to gather information about the colleges, the courses offered, infrastructure available, teaching faculty, laboratory facilities, hostel facilities and any other information which would help him / her in narrowing his options. The distance from his / her house, the mode of transport, the hostel facilities and the environment etc are also prime factors in deciding priority of options.

**The complete process of seat allotment hinges on the priority of options entered by the candidate. If option entry is faulty then the candidate stands a chance of losing best available seat as per his rank and category. The candidate is advised to take utmost care while entering priorities for college and course.**

### **18.8 Additional Instructions on Entering of Medical / Dental options**

**18.8.1** Before entering the options for medical and dental courses, please note that each college will have four different categories of seats. (Except Government Colleges)

**18.8.2** Likewise please note that each category of seats has a separate fee structure (Government, Private, NRI, Others). Also note that the seats in Government colleges are also categorized as G seats. However the fee structure for G seats in Government colleges & G seats in private colleges will be different.

**18.8.3** The college codes ending with “... MG” are indicating Government seats in Government colleges and Government share of seats in private colleges; the college codes ending with “...MP” are indicating Private seats; the college codes ending with “...MN” are indicating NRI seats and the college codes ending with “...MQ” are indicating the Other seats.

**18.8.4** The candidates who wish to enter the options please ascertain the college, course and category of seats (G, P, N, Q) and act accordingly.

## **19. MOCK SEAT ALLOTMENT:**

*After the entry of options are completed*, based on the options entered by the candidates in the order of merit and by following the Roster System MOCK ALLOTMENT will be carried out as per the procedures explained in this Information Bulletin. This Mock Seat Allotment is only an INDICATIVE seat status which candidate may or may not get in the real allotment. It will help the candidate to revise, update, add or delete already the entered options.

**All the candidates who have got the verification slip must enter their final options before the last date prescribed.** Candidates who got the verification slip but did not enter the options can also enter the options if they are interested.

Please note the any candidate will not be able to change their options or to add new options after the last date and time fixed to do so.

Based on the Mock Allotment a candidate can get an indicative allotment of college / course / stream as per his / her priority of options. This gives a clear idea to the candidate to change or retain the entered options. Candidates can get to know that the other candidate with lower merit is allotted a seat which he / she was eligible but for his / her not entering that option. Therefore, candidates will be given one more chance to change the priority of options or deletion or addition or re-ordering of the options.

Candidates are required to verify their allotted seat status on the KEA Website <https://cetonline.karnataka.gov.in/kea/ugneet2026>, if they desire they are free to change, reorder, delete and add to their choices of courses / colleges as per their preference.

Even though the candidate may not like to modify the options after the Mock Allotment, he / she may not get the same seat during the Real Allotment as other candidates may change their earlier entered options.

Candidates can enter their CET Number to know their mock result. It will be hosted on the website <https://cetonline.karnataka.gov.in/kea/ugneet2026>, Candidates will also be able to view the details of seat allotted as per their options priority. Candidates can also view the college-wise, course-wise, category-wise cut off rank of Mock Allotment. Candidates, who have not been allotted any seat in the Mock allotment, should verify the options entered by them and are advised to enter more options in which they are interested.

This is only an indicative exercise; candidates need not report to the college, but should wait for the real allotment result. However, ALL CANDIDATES CAN CONTINUE TO ACCESS THEIR LOGIN ACCOUNTS TO UPDATE/ ADD/DELETE/ GIVE FRESH OPTIONS TILL THE LAST DATE AND TIME FOR OPTION ENTRY FOR REAL ALLOTMENT.

**Due to change in the options by candidates after Mock Allotment, one may not get the same seat in the real allotment as was allotted in the mock allotment.**

## **20.ALLOTMENT OF SEATS AND ADMISSION:**

After the entire iteration of all the discipline in all the three phase is complete the final list will be announced on the website and this is known as the First Round. Therefore, many iteration may take place in one round as per the **CHOICE** of the candidate and as per the availability of seats. The candidate can track down the movement of seats in the different iteration stages to satisfy himself that the best of the **CHOICES** is allotted to him. Virtual tracking of the process of allotment by the computer can be viewed by the candidate after allotment. This ensures transparency in the entire allotment stage and KEA is known for its motto **Trust through Total Transparency**.

Admission to Government seats shall be made in accordance with the Karnataka Selection of Candidates for Admission to Government Seats in Professional Educational Institutions Rules, 2006 (in short CET-2006 Admission Rules) as amended from time to time and therefore the details and instructions contained in this Information Bulletin are subject to the said Rules and Government orders. In case of any discrepancy, the Rules shall prevail.

As per the seat matrix issued by the Government, the seat allotment to these courses will be done ONLINE in the order of merit / rank and based on the options entered by the candidates through KEA Web-portal.

Detailed information about entering preferences/options and mock seat allotment has been explained in the previous pages for the information of the candidates. As a continuation of that, detailed information about 2 + 1 rounds followed by Stray Vacancy Round, stages are given below;

That is,

**1. FIRST ROUND SEAT ALLOTMENT**

**2. SECOND ROUND SEAT ALLOTMENT**

**3. THIRD ROUND / MOP-UP ROUND SEAT ALLOTMENT**

**4. STRAY VACANCY ROUND SEAT ALLOTMENT**

Required information like rules, instructions, guidelines, procedures, schedule etc. for each round of seat allotment for various professional courses will be published on the KEA Website from time to time. Candidates should read the instructions carefully and follow them accordingly.

**21. FIRST ROUND SEAT ALLOTMENT:**

The first round of seat allotment will be made as per the priority of options saved by the candidates, merit and roster system of the candidate. First round results will be published on the KEA Website for the information of the candidates.

The candidate here has 4 **CHOICES**. Read the following four Choices in detail in next pages.

- 21.1 After verifying the first round seat allotment actual results on the KEA Website, the candidate can take the decisions as detailed below:
- 21.2 After the first round seat allotment, four different CHOICES will be given to the candidates who have been allotted seats. Candidate should select any one CHOICE out of the four CHOICES that suits them.
- 21.3 But before selecting any CHOICE, candidates please read and understand the implication of each CHOICE and then select the appropriate CHOICE. If a candidate fails to exercise any of the following FOUR CHOICES within the stipulated date and time, then the seat allotted to such candidate stands cancelled automatically without any further notice in this regard and he/she will not be allowed to participate in further rounds.
- 21.4 To exercise the Choices or to download the Challan or to download the Seat Confirmation Slip or to make payment in the bank or to download the admission order from the college portal, candidate need not visit KEA, these activities have to be executed from selecting the appropriate link in the KEA Website.
- 21.5 The explanation of the CHOICES for the candidates allotted seats in the first round and the steps taken after selecting the CHOICES are given in the following pages.
- 21.6 After the first round of seat allotment, candidates can participate in the next round by selecting the appropriate CHOICE.
- 21.7 If the candidates opt for CHOICE-1 for the seat allotted in the first round, such candidates will not be considered for the second round of UGCET courses or UGNEET courses.

**Instructions to the candidates who have NOT been allotted a seat**

- 21.8 Candidates who have been OPTIONS in the first round but have not been allotted any seat will not have any CHOICE to choose, they can participate in the next round.
- 21.9 But after the start of the second round of seat allotment, they have to compulsorily log in to the login portal and selected the consent form.
- 21.10 If a candidate has not logged in to the online portal at least once, such candidate will be considered as not interested in participating in the second round, the first round OPTIONS will not be considered and also will not be considered for seat allotment.

**21.11 OPTIONS ENTERED DURING FIRST ROUND:**

The options entered earlier will continue to be valid for second round of online seat allotment. Candidates will not be allowed add options again. However, options can be deleted or changed or the order can be changed.

**IMPORTANT and APPLICABLE TO ALL THE ROUNDS OF SEAT ALLOTMENT**

Candidates are advised to visit KEA Website for seats availability / vacant seats for allotment before participating as well as to know about the **fee structure** in different colleges / category of seats. Candidates are also advised to exercise options after knowing / confirming the fee structure, and after discussion with their parents.

The candidates who allotted seat either in first round or in the second round or in the 3<sup>rd</sup> round (Mop-up) or in the Stray Vacancy Round should compulsorily report to the selected college as the seat allotment is based on the priority of options entered by the candidates. Mere not reporting to the selected college will not be presumed by the candidates that they have surrendered the seat to KEA and it is tantamount of blocking of seat and it attracts the penalty. Further, Government may initiate legal action against such candidates for blocking the seats. Hence please note the following;

1. Candidates should not claim any ignorance on allotment of seats and they should not reject the allotted seats. Since the seat is allotted to candidates based on the options entered by them and order of merit.
2. Penalty will be applicable as per rules to the candidates who wish the surrender the seat after the announcement of results.
3. Hence, the candidates are advised to enter the options carefully in the order of preference and they are interested to join.
4. Do not share the confidential materials such as CET No., Application Number, USER ID, Password, Seat Confirmation Slip etc with any third person.

### CHOICES for FIRST ROUND

**CHOICE-1:** I am 100% satisfied with the seat allotted in the first round and will join the college; I do not need any change. I also do not want to participate in the next rounds (for courses like UGNEET- Medical or Dental or Homoeopathy or UGCET-Engineering / Architecture / Farm Science / Veterinary / Pharmacy / B.Sc Nursing, Naturopathy and Yoga, BPT, BPO, Allied Health Science, D-Pharma etc.), hence I should not be considered for seat allotment in any of the next rounds. I confirm that I will pay the fee for the seat allotted in the first round, download the Confirmation Slip and then get the OTP through the college portal login by Online Face Recognition, verify the eligibility, download the admit card and get admission within the stipulated date.

**Action:** If the candidates are going to take the above steps, they can select CHOICE-1 from the specified link on the KEA Website and take the next step.

Any Choice-1 selected candidate fails to pay the fees or paid the fees but failed to download the Confirmation Slip or fails to report to the College, he / she has no claim further on such allotment, revert back to the seat matrix, and he / she will not be considered for allotment of seats in the subsequent round, fee paid if any will be forfeited.

**Implication: Not eligible to participate in the subsequent rounds.**

**Important:** Candidates are advised to choose this option only if they are certain, as they will not be allowed to re-enter the Option Entry Process for UGCET-2026/UGNEET-2026.

The candidates who exercise **CHOICE-1** Should follow the guidelines detailed below:

- a. If satisfied, exercise **CHOICE-1** on the KEA Web-portal.
- b. Download / print the Challan from the KEA website.
- c. In the Challan, the details of the candidate will be pre-printed, such as Name, CET Number, College / Course Allotted details, Fee to be paid, Bank Account Number. Candidate has to confirm the printed details and affix the signature on the Challan.
- d. Pay the prescribed fee.
- e. Download the Confirmation Slip, report to college with all the necessary original documents (with two sets of photocopies) to take admission.
- f. After verifying all the original documents, the college will get the details of the candidate in their official login (College Portal), verify the photo (Online Face Recognition) and then send an OTP to the candidate's mobile number via WhatsApp.
- g. After OTP verification, the college will download the provisional admission letter from their portal. (Candidates will not be allowed to download the admission letter)
- h. After these steps, the candidate's admission process is complete and he/she will not be eligible to participate in any further rounds.

**Steps to be followed by CHOICE-1 Candidates – Rules**

First step – Fee payment

Second step – Downloading the Confirmation Slip.

Third step – Reporting to the college in person for admission (with all original documents and mobile)

Fourth step – Verification of the photo (Face Recognition) – Then verification of the OTP sent to the candidate's mobile number via WhatsApp

Fifth step – After OTP verification, the college authority will be able to download the admission order from their login portal.

**Admission will be considered final only after all the above steps are followed.**

**CHOICE-2:** I want the seat allotted in the first round but I will participate in the second round to get a better seat. If any seat is allotted in the higher order options on the basis of merit in the second round, I will take the seat allotted in the second round. In case no seat is allotted on the basis of merit in the second round, I confirm that the seat already allotted in the first round will remain.

**Action:** If the candidate decide / take action in the above manner, they can participate in the second round by selecting CHOICE-2 in the specified link on the KEA Website.

**Explanation:** Choice-2 candidates are participating in the second round by holding the first round allotted seat for higher order options. In the second round, if higher option seat are allotted then earlier allotted seat gets cancelled automatically OR if higher option seat are not allotted then earlier allotted seat shall remain in candidates favour. **There is no CHOICE between the earlier allotted and newly allotted seats.**

**Important:** Consequential vacancies that arise after their turn cannot be claimed. Fresh options entry will be permitted only when the new college / courses are included in the seat matrix after the allotment of first round. **Eligible to participate in the subsequent round keeping the seat allotted on hold. However, if a seat in the higher options gets allotted the candidate loses his old seat.** The candidates who exercise **CHOICE-2** should follow the guidelines detailed below:

- The candidates who exercise **CHOICE-2** need not pay the fees for the allotted seat in the first round.
- Candidates who choose **CHOICE-2** will retain the seat allotted to them in the first round and will be considered for seat up-gradation in the second round. If a seat from any of their higher-order options is allotted in the second round, the seat allotted in the first round will be automatically cancelled and replaced by the new allotment. If no higher-preference option is allotted, the candidate will continue to hold the seat allotted in the first round.

- Higher order options means, if a candidate has entered 180 options, and the seat is allotted for his / her priority number 123 in the first round, then the priority number 1 to 122 are the higher order options. The lowered options i.e., from 124 to 180 get deleted automatically.
- If any of the Higher Order Options are not allotted, then the seat allotted to them in the first round will remain with the candidate.
- Candidates can alter / delete / reorder / modify the higher order options in the second round option entry portal.

**CHOICE-3:** I am not satisfied with allotted seat but wish to participate in the next round with all the already entered options except the allotted options by surrendering the allotted seat and also re-ordering of already entered options.

**Implication: Eligible to participate in the subsequent round by rejecting the allotted seat.**

After the commencement of process of second round option entry, the candidates should login and agree to the terms and conditions. Only after logging to the option entry portal, candidate is allowed to alter / modify / reorder / delete the already entered options as per his / her choice. All the options entered by the candidates in the first round will be shown (except the allotted option in the first round), the candidates can modify only the options they want in any order. There is no need to keep the options that are not required, they can be removed. The options that you remove will remain on your left-hand side screen and such options will not be considered. That is, you can change any options or modify the priority measures or remove any options if you do not want them.

**NOTE:** Consequential vacancies that arise after their turn cannot be claimed. **Chances of getting lower order options is subject to availability of seats as the other candidates next to your rank might have entered those options and seat would have been allotted to them based on merit.**

The candidates who exercise **CHOICE-3** should follow the guidelines detailed below:

- The candidates who exercise **CHOICE-3** need not pay the fees for the allotted seat in the first round. The candidates who exercise **CHOICE-3** are NOT satisfied with the allotted seat.
- The candidates who exercise **CHOICE-3** are participating in the second round by rejecting the seat allotted to them in the first round.
- Only after logging to the option entry portal, candidate is allowed to alter / modify / reorder / delete the already entered options as per his / her choice.

**CHOICE-4:** I am not satisfied with the seat allotted to me by KEA, and I have secured admission through another institution/process. Therefore, I wish to withdraw from the KEA counseling process and request that I should not be considered for seat allotment in any further rounds.

**Implication:** Not eligible to participate UGCET-2026 or UGNEET-2026 subsequent round and no hold on the allotted seat and seat allotted earlier will get cancelled.

## **22. SECOND ROUND SEAT ALLOTMENT: (No new registration / enrolment)**

**22.1** Three types of candidates would be eligible to participate in the second round of seat allotment. (a) **Those who have selected Choice-2 in the first round,** (b) **Those who have selected Choice-3 in the first round and** (c) **Those who have not been allotted any seat in the first round.**

**22.2** The schedule for the second round of seat allotment will be published on the KEA Website. Candidates should then proceed as per the schedule.

**22.3 Candidates who have selected Choice-2 in the first round shall participate keeping the seat allotted to them.**

**22.3.1** The options with priority entered by the candidate in the first round will be shown on the option entry module by obtaining the candidate credentials. Candidate may delete or alter order of higher options.

**22.3.2** All the above higher order options will be considered for allotment of seats. For example, if a candidate has been allotted a seat in the First round for his / her 115<sup>th</sup> option, all the above higher order options means, option number 1 to 114 will only be considered for allotment.

**22.3.3** All the lower order option from 116 to the last entered options will not be considered for allotment.

**22.3.4** Candidate can modify / alter / delete the priority of options from 1 to 114. If any of the options from 1 to 114 is available in the order of merit then computer will allot the seats to that candidate and automatically the earlier allotted seat will get cancelled and added to the seat matrix and it will be offered to the next candidate below and to subsequent candidates.

**22.3.5** If a candidate fails to get any of the options from 1 to 114 then the seat allotted to him / her in earlier round for 115<sup>th</sup> option will remain with him / her.

**22.3.6** Always, the computer moves towards upward direction so that the candidate will get the best of the best options entered by him / her. (Options 1 to Option 114)

**22.3.7** Candidates should not claim any ignorance on allotment of seats and they should not reject the allotted seats since the seat is allotted to candidates based on the options entered by them and order of merit.

**22.3.8** For any reason candidates will not be allowed to continue in their earlier allotted colleges. As already informed the earlier allotted seat will not be in their favour and therefore such candidates should invariably report to the allotted colleges.

**22.3.9** Candidates are advised to modify / delete / re-order the options they want to select whether the seats shown in the seat matrix or not, only for the reason that consequential vacancies may arise during allotment process and the candidates will have a chance of getting a better seat if they have entered the options.

**NOTE:** Consequential vacancies that arise after their turn cannot be claimed.

**22.3.10** The candidate will be allowed to add new options for any colleges and course that came into the seat matrix after the first round. Candidates who are participating in this round imply they are looking for a better seat than the allotted seat in the earlier round. If the candidate does not get any seat in this round then the seat allotted to him / her in the earlier round if any stands confirmed.

**22.3.11** If the candidate gets a seat in the colleges entered by him / her in this round, the seat opted by him / her in this round will be confirmed and the seat held by him / her in the earlier round gets cancelled automatically.

**22.3.12** Please note that if any seat gets allotted in this round as per merit and options entered by the candidate, there is no chance of getting back the earlier allotted seat.

**Additional Important Instructions for First Round CHOICE 2 Candidates**

- (a)** The **CHOICE 2** candidates are participating by holding a seat allotted in the First Round, if any seat is allotted to them in this round then their First Round seat gets added to the seat matrix immediately and is offered to the next eligible candidates in the order of options and priority of options.
- (b)** While modifying the order of options or deleting the options (adding the new options in case of new college / course added to the seat matrix) candidates are advised to give only such options that are better than his / her allotted seat. If the modified / added option gets allotted they lose their old seat. If none of the seats are available then the candidate's earlier seat is retained.

- (c) For **CHOICE 2** candidates the seat allotted in the First Round will be considered as last option. The **CHOICE 2** candidates should be very careful while submitting the options. One should understand that the seat allotted in the First Round will become the last option, it means all the higher options saved by the candidates will be treated as options for seat allotment.
- (d) All the higher order options will be displayed for entry of options, if any candidate is intending to retain the same seat which is allotted in the First Round, then he / she has to delete all such options which is displayed on the option entry portal, then the seat allotted in the First Round will be retained in this round also.

**Candidates are advised to preserve the print out of the finally submitted options.**

- 22.4 The seats which remain unfilled after first round seat allotment will be published on the KEA Website.
- 22.5 As the seats which may get cancelled /forfeited/newly added will also be published from time to time, candidates are advised to keep checking the KEA Website for updates on the availability of seats.
- 22.6 Further, the seats will be considered for allotment as a result of any CONSEQUENTIAL VACANCY that may arise during the seat allotment. Therefore, candidates are advised to retain all the options they are interested in choosing irrespective of the seats shown in the seat matrix.
- 22.7 **(b) the candidates who have selected CHOICE-3 will be participating without holding any seat with them.**
- 22.7.1 After the process of commencement of options entry in the 3rd round starts, after mandatory login and consent in the option entry portal, CHOICE-3 candidates will be shown all the preferences/options entered by the candidates in the first round (except for the options rejected / cancelled by the candidate as allotted in the first round).
- 22.7.2 Candidates can change the options or modify the priority numbers or remove any options if they are not required. The options that you remove will remain on your left side screen and such options will not be considered. That is, you can change any options or modify the priority numbers or remove any options if they are not required.

**22.7.3** As the seats which may get cancelled /forfeited/newly added will also be published from time to time, candidates are advised to keep checking the KEA Website for updates on the availability of seats.

**22.7.4** Further, the seats will be considered for allotment as a result of any CONSEQUENTIAL VACANCY that may arise during the seat allotment. Therefore, candidates are advised to retain all the options they are interested in choosing irrespective of the seats shown in the seat matrix.

**Additional Instructions to candidates who have exercised CHOICE-3 in first round.**

- **CHOICE-3** candidates are participating in this round without holding any seat allotted to them in the first round, if any seat is allotted to them in this round then such seat will be confirmed in their favour or if no seat is allotted to them then they will not be having any seat in their favour.
- All the already entered options except the allotted option will be displayed on the option entry screen.
- All the options means, presume that the candidate has entered 180 options, and the seat is allotted if I am not satisfied with the seat allotted to me by KEA, and I have secured admission through another institution/process. Therefore, I wish to withdraw from the KEA counseling process and request that I not be considered for seat allotment in any further rounds or his / her priority number 123 in the first round, then the priority number 1 to 180 except 123 will be displayed on the option entry screen.
- Candidates can alter, modify, delete or re-order the already entered options.
- While modifying the order of options or deleting the options (adding the new options in case of new college / course added to the seat matrix) candidates are advised to give only such options that are better than his / her allotted seat and for those options candidates are willing to join the college / course in case the seat is allotted.

**22.8 (c) Those who have not been allotted any seat in the first round.**

Candidates who have not got any seat in the first round should compulsorily log in to the login portal and select the agree /consent form on or before the last date prescribed for entry of options and prioritize the options, save and submit.

**22.8.1** If a candidate has not logged in to the online portal at least once, such candidate will be considered as **not** interested in participating in the second round, the first round OPTIONS will not be considered and also will not be considered for seat allotment.

**22.8.2** As the seats which may get cancelled /forfeited/newly added will also be published from time to time, candidates are advised to keep checking the KEA Website for updates on the availability of seats.

**22.8.3** Further, the seats will be considered for allotment as a result of any CONSEQUENTIAL VACANCY that may arise during the seat allotment. Therefore, candidates are advised to retain all the options they are interested in choosing irrespective of the seats shown in the seat matrix.

#### **Important Instructions to Candidates – Regarding Second Round**

**The following types of seats are made available for Second Round Seat Allotment.**

- a. Unfilled seats of First Round.
- b. Choice-3 and Choice-4 seats.
- c. Not joined seats
- d. Newly added seats if any.
- e. Consequential Vacancies.

**The following types of candidates are not eligible to participate in the 2<sup>nd</sup> Round**

- a. Candidates who have failed to exercise any **CHOICE** even after allotment of seats in the First Round.
- b. Candidates who have exercised **CHOICE** 1 after seat allotment in First Round but failed to pay / download the Confirmation Slip.
- c. Not entered any options either in first round.

#### **22.8.4 AFTER VERIFYING THE RESULTS OF THE SECOND ROUND OF SEAT ALLOTMENT ON THE WEBSITE, CANDIDATES CAN TAKE DECISIONS AS EXPLAINED BELOW.**

- a. After the announcement of the results of the second round of seat allotment, candidates will have only **Choice-1** or **Choice-4** to select.
- b. Candidates who select **Choice-1** should get admission to the allotted seat. If they are interested in seat up gradation, they can participate in the third round of seat allotment by logging in.
- c. If a candidate does not take **Choice-1**, but wants to participate in the third round, he can cancel the seat allotted in the second round by paying penalty and log in to the third round and pay the registration fee again.
- d. During the third round of seat allotment only the colleges in which the candidate wants to join should be entered, because the seat allotment is done on the basis of merit and considering the options entered by the candidates, the allotted seat cannot be denied. Therefore, candidates should carefully submit their options in the order of priority.

### CHOICES for SECOND ROUND

**CHOICE-1:** I am 100% satisfied with the seat allotted in the second round and will join the college, I do not need any change. I also do not want to participate in the next rounds (for courses like UGNEET- Medical or Dental or Homoeopathy or UGCET-Engineering / Architecture / Farm Science / Veterinary / Pharmacy / B.Sc Nursing, Naturopathy and Yoga, BPT, BPO, Allied Health Science, D-Pharma etc.), hence I should not be considered for seat allotment in any of the next rounds. I confirm that I will pay the fee for the seat allotted in the first round, download the Confirmation Slip and then get the OTP through the college portal login by Online Face Recognition, verify the eligibility, download the admit card and get admission within the stipulated date.

**Action:** If the candidates are going to take the above steps, they can select CHOICE-1 from the specified link on the KEA Website and take the next step.

Any Choice-1 selected candidate fails to pay the fees or paid the fees but failed to download the Confirmation Slip or fails to report to the College, he / she has no claim further on such allotment, revert back to the seat matrix, and he / she will not be considered for allotment of seats in the subsequent round, fee paid if any will be forfeited.

The candidates who exercise **CHOICE-1** Should follow the guidelines detailed below:

- a. If satisfied, exercise **CHOICE-1** on the KEA Web-portal.
- b. Download / print the Challan from the KEA website.
- c. In the Challan, the details of the candidate will be pre-printed, such as Name, CET Number, College / Course Allotted details, Fee to be paid, Bank Account Number. Candidate has to confirm the printed details and affix the signature on the Challan.
- d. Pay the prescribed fee.
- e. Download the Confirmation Slip, report to college with all the necessary original documents (with two sets of photocopies) to take admission.
- f. After verifying all the original documents, the college will get the details of the candidate in their official login (College Portal), verify the photo (Online Face Recognition) and then send an OTP to the candidate's mobile number via WhatsApp.
- g. After OTP verification, the college will download the provisional admission letter from their portal. (Candidates will not be allowed to download the admission letter)
- h. After these steps, the candidate's admission process is complete and he/she will not be eligible to participate in any further rounds.

**STEPS TO BE FOLLOWED BY CHOICE-1 CANDIDATES – RULES**

First step – Fee payment

Second step – Downloading the Confirmation Slip.

Third step – Reporting to the college in person for admission (with all original documents and mobile)

Fourth step – Verification of the photo (Face Recognition) – Then verification of the OTP sent to the candidate's mobile number via WhatsApp

Fifth step – After OTP verification, the college authority will be able to download the admission order from their login portal.

**Admission will be considered final only after all the above steps are followed.**

**CHOICE-4:** I am not satisfied with the seat allotted to me by KEA, and I have secured admission through another institution / process. Therefore, I wish to withdraw from the KEA counseling process and request that I should not be considered for seat allotment in any further rounds.

**Implication:** Not eligible to participate UGCET-2026 or UGNEET-2026 subsequent round and no hold on the allotted seat and seat allotted earlier will get cancelled.

**Instructions to the candidates who have NOT been allotted a seat**

- Candidates who have entered the **OPTIONS** in the second round but have not been allotted any seat will not have any **CHOICE** to choose, they can participate in the next round.
- But after the start of the third round of seat allotment, they have to compulsorily log in to the login portal and selected the consent form.

### **23. THIRD ROUND / MOP-UP ROUND SEAT ALLOTMENT: (No new registration / enrolment)**

After the publication of the final results of the second round, some candidates may cancel the seats allotted to them in the second round for various reasons. As per the counseling conditions and the counseling process adopted in previous years, such cancelled seats are considered for the third round of counseling. In the previous years; candidates who were allotted seats in the second round were not eligible to be considered for the third round of seat allotment (upgradation).

However, as per the recent orders of the Hon'ble High Courts, candidates who have already been admitted to seats allotted in the second round shall also be eligible to participate in the third round of counseling. Accordingly, the counseling conditions and guidelines for admission to Medical / Dental courses for the academic year 2026 have been revised and published as below:

1. Candidates who have been allotted seats in the second round must compulsorily take admission in the college by paying the prescribed fee.
2. Candidates who have been admitted in the college will be allowed to participate in the seats available in the third round (Upgradation).

**IMPORTANT INSTRUCTIONS TO CANDIDATES:** Candidates who are participating in this round mean they are looking for up-gradation of a seat than the allotted seat in the earlier round. If the candidate does not get any seat in this round then the seat allotted to him / her in the earlier round if any stands confirmed.

- i. Candidates are advised to carefully retain all the options they wish to select, even if the seats are not currently shown in the seat matrix. This is because consequential vacancies may arise during the allotment process, and candidates may have an opportunity to secure a better seat if they have already included those options.
- ii. Candidates shall not claim ignorance regarding the allotment of seats or reject the seats allotted to them, as seat allotment is made strictly based on the options exercised by the candidates and their order of merit.
- iii. For any reason candidates will not be allowed to continue in their earlier allotted colleges. As already informed the earlier allotted seat will not be in their favour and therefore such candidates should invariably report to the allotted colleges.
- iv. If the candidate gets a seat in the colleges entered by him / her in this round, the seat opted by him / her in this round will be confirmed and the seat held by him / her in the earlier round will get cancelled automatically.
- v. Please note that if any seat gets allotted in this round as per merit and options entered by the candidate, **there is no chance of getting back the earlier allotted seat.**

**PROCEDURE TO BE COMPLETED AFTER THE 3RD-ROUND SEAT ALLOTMENT:**

1. There will not be any **CHOICE** to exercise to the candidates.
2. Candidates who have allotted seat in any discipline are required to pay the prescribed fees (if not paid) and should compulsorily report to the colleges on or before the last date mentioned in the admission order and should update the details through their log-In-Id to KEA or they lose their allotted seats.
3. If any candidate fails to report to the college after allotment of seats in the 3<sup>rd</sup> Round / Mop-up round, legal action will be initiated against such candidate in accordance with law.

**STEPS TO BE FOLLOWED BY 3<sup>RD</sup> ROUND SEAT ALLOTTED CANDIDATES**

First step – Fee payment (if not paid)

Second step – Downloading the Confirmation Slip.

Third step – Reporting to the college in person for admission (with all original documents and mobile)

Fourth step – Verification of the photo (Face Recognition) – Then verification of the OTP sent to the candidate's mobile number via WhatsApp

Fifth step – After OTP verification, the college authority will be able to download the admission order from their login portal.

**Admission will be considered final only after all the above steps are followed.**

**24.STRAY VACANCY ROUND: (New registration / enrolment allowed)**

Subject to availability of seats

**Detailed instructions and procedures will be published later**

Eligibility to participate in each round is subject to the conditions stipulated from time to time by Government / MCC. KEA will not be held responsible in this regard.

**25. SPECIAL NOTE:**

- ❖ No requests will be accepted for cancellation of seats allotted in previous rounds after the last date fixed for entering the options for the third round of seat allotment. If a candidate fails to get admission in the college after being allotted a seat in the 3<sup>rd</sup> round or if he/she wishes to cancel it or does not report to the college, the candidate will have to pay a penalty as per the rules – he/she will not be eligible to participate in the counseling of other institutions.

- ❖ Candidates are informed several times in each round that they should know the fee structures and then enter their options. However, the candidates should not request KEA to cancel the seats by quoting the reasons that they do not know the details of the fees or they do not want the seat.
- ❖ Therefore, it is advised that candidates should pay attention to the fees and then enter only such options in which they are interested in joining the college-course in priority order. If a candidate does not want the college/course allotted to him/her or leaves the college after joining, it will be considered as a serious lapse in the maintenance of social responsibility. Please note that other candidates are waiting in the queue for seat allotment.

## **26. A NOTE ON SEAT CANCELLATION, REFUND AND FORFEITURE OF FEE:**

- (1) If a candidate who has been allotted a Medical / Dental / AYUSH seat in any discipline in the First Round and who has reported to the college, wishes to surrenders / cancel the seat before the last date notified for entry of options for the Second Round, the Executive Director, shall deduct Rs.5,000/- penalty and refund the remaining fee paid.
- (2) If a candidate who has been allotted a Medical / Dental / AYUSH seat in any discipline in the First Round / Second Round and who has reported to the college or not, surrenders the seat after the completion of Second Round but before the last date fixed to enter the options for third round, the Executive Director, shall deduct Rs.5,000/- as processing fee and Rs.5,000/- penalty.
- (3) If a candidate who has been allotted a Medical / Dental / AYUSH seat in any discipline in the First Round / Second Round, and who has reported to the college or not, surrenders the seat after the last date fixed to enter the options for Third Round, the Executive Director, shall deduct Rs.1,00,000/-, including Rs.5,000/- as processing fee and Rs.5,000/- penalty.
- (4) If a candidate who has been allotted a seat in any discipline in the First Round / Second Round / Third Round, and who has reported to the college or not, surrenders the seat after the last date fixed to enter the options for Stray Vacancy Round / or surrenders after completion of Stray Vacancy Round, the Executive Director, shall forfeit the one year fee, and candidate has to pay a penalty of Rs.1,00,000/- in case of Medical, Rs.50,000/- for Dental, Rs.25,000/- for AYUSH courses including Rs.5,000/- as processing fee and Rs.5,000/- penalty. The candidate who surrenders the seat allotted in the Third Round, the Executive Director, shall forfeit the entire fee paid.

(5) As per rule 12 (2) of CET-2006 rules, payment of penalty is mandatory and no exemption on penalty payment to any category candidate. All the candidates have to pay the total fees fixed.

**(6) No surrender or cancellation of seat shall be accepted after 3<sup>rd</sup> round / Mop-up round.**

(7) If a candidate reports to the college and later on leaves the college he / she have to necessarily surrender the seat back to KEA only. It is the endeavor of KEA to see that subsidized Government Quota seats are accessible and available to all meritorious students. Hence failing to surrender the seat back to KEA will be viewed as a breach of contract and severe lack of social responsibility.

(8) No surrender or cancellation of seat shall be accepted, unless the candidate surrenders the original seat confirmation slip / admission order issued by the KEA, original Bank Challan and original Verification Slip.

## **ANNEXURE - 10**

### **PERSONS WITH DISABILITY RESERVATIONS**

The candidates belonging to PH category are hereby informed that as per the Graduate Medical Education Regulation (GME) of MCI, it has been decided by competent authority in Ministry that 5 percent reservation (in Government seats) will be given to all physically handicapped candidate as per the benchmark of Social Disability Act -2016. Hence, this is to inform all the PH category candidates that 21 disabilities incorporated in "The Rights of Persons with Disabilities Act- 2016" are considered as eligible criteria, if they go beyond 40 percent disability.

As per the Rights of Persons with Disabilities Act- 2016

**1. Physical Disability.—**

- a. Locomotor disability** (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including— (a) "leprosy cured person" means a person who has been cured of leprosy but is suffering from— (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity; (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity; (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly; (b) "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth; (c) "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less; (d) "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue; (e) "acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.
- b. Visual impairment—** (a) "blindness" means a condition where a person has any of the following conditions, after best correction— (i) total absence of sight; or (ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or (iii) limitation of the field of vision subtending an angle of less than 10 degree. (b) "low-vision" means a condition where a person has any of the following conditons, namely:— (i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or 34 THE GAZETTE OF INDIA EXTRAORDINARY [PART II— (ii) limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.
- c. Hearing impairment—** (a) "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears; (b) "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
- d. "speech and language disability"** means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.

2. Intellectual disability, a condition characterised by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including— (a) "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia; (b) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.
3. Mental behaviour,— "mental illness" means a substantial disorder of thinking, mood, perception orientation or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by sub normality of intelligence.
4. Disability caused due to— (a) chronic neurological conditions, such as— (i) "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelisation and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other; (ii) "parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine. (b) Blood disorder— (i) "haemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterised by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding; (ii) "thalassemia" means a group of inherited disorders characterised by reduced or absent amounts of haemoglobin. (iii) "sickle cell disease" means a hemolytic disorder characterised by chronic anaemia, painful events, and various complications due to associated SEC. 1] THE GAZETTE OF INDIA EXTRAORDINARY 35 tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.
5. Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
6. Any other category as may be notified by the Central Government.
7. The candidates are required to appear COMPULSORILY for Medical examination before a Committee comprising of the Executive Director, KEA, Bangalore, as Chairman, Assistant Commissioner (Disability Department) and Specialists from the department of Orthopedics. The Medical Board shall examine the candidate and certify regarding the percentage of disability and the decision of the Medical Board will be final. For this proviso, persons with the disability shall have the same meaning assigned to it in the "The Rights of Persons with Disabilities Act- 2016".
8. The Seats under PWD quota will be allotted to eligible PWD on inter-se-merit. Candidates with disability below 40% candidates will not be eligible for selection of seats under PWD quota.
