PROSPECTUS FOR ADMISSION INTO MDS COURSES UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2026-27

I. REGULATIONS:

The following are the regulations for admission into MDS courses under Competent Authority Quota for the academic year 2026-27 into Dental Colleges affiliated to KNR University of Health Sciences in the State of Telangana.

II. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA:

The number of MDS seats available for the academic year 2026-27 under Competent Authority Quota will be in accordance with the orders of NDC/DCI/GOI/ Govt. of Telangana / KNRUHS. The Seat matrix for the year 2026-27 will be displayed in the University website before exercising web options for counseling.

In case any new seats in MDS Courses are permitted by NDC/Government of India in colleges affiliated to KNRUHS for the academic year 2026-27, those seats will also be filled up. **NO FURTHER NOTIFICATION WILL BE ISSUED.**

III. ELIGIBILITY:

The candidates who fulfill the following criteria are eligible for admission into MDS courses. They have to apply on-line and upload the original certificates for Competent Authority Quota seats in Dental colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Warangal.

The candidates who have qualified in NEET-MDS-2026 examination with the following `cutoff scores and above are eligible to apply.

Category	Minimum eligibility criteria	Cut off Score
General Category	50 th percentile	308
General PWD	45 th percentile	289
SC/ST/OBC (Including PWD of SC/ST/OBC)	40 th percentile	271

- IV.** 1. The Candidate should be Indian National, Person of Indian Origin/Overseas Citizen of India card holder and shall fulfill the following provisions:
- a) If the candidate has studied in Educational Institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in the relevant qualifying examination.
 - b) Local area herein means the State of Telangana.
- 2. BDS Degree should be recognized by the Dental Council of India.
 - 3. Should have completed internship on or before **31-05-2026**.
 - 4. In case of service candidates, service rendered shall be calculated as on **31-05-2026**.
 - 5. Must have registered with National Dental Commission/Dental Council of India.
 - 6. Candidates who are already studying MDS course shall not be permitted for registration.
 - 7. The verification fee and registration fee once paid will not be refunded or adjusted to a future date. Therefore, candidates are advised to check eligibility conditions thoroughly before applying for determining merit position in respective categories for State quota seats using NEET MDS-2026 Rank.
 - 8. Candidates admitted into BDS course at Government Dental College, Hyderabad under AU/SVU quota shall not be considered as Local candidates (as per G.O.Rt. No. 439 HM&FW (C1) dated 03-08-2024)

Note: If a candidate is found to have submitted false information or concealed any relevant information regarding this matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be taken by the University.

V. RESERVATIONS:

1. 15%, 10%, 29% seats of Post Graduate Dental Degree MDS Courses are reserved for SC (SC Group 1-1%, SC Group 2-9%, SC Group 3-5%), ST and BC (BC-A-7%, BC-B-10%, BC-C-1%, BC- D-7% and BC-E- 4%) candidates respectively, which are called vertical reservations.
2. Candidates claiming reservations under SC/ST/BC categories shall upload latest permanent social status certificate as specified along with online application form issued by competent authority of Government of Telangana. The social status of SC/ST/BC candidates shall be subject to the scrutiny as per G.O.Ms.No.58 SW (J) Dept. Dt: 12-5-97.
3. 5% seats shall be reserved for Persons with Disabilities (PWD) candidates respectively, which are horizontal reservations for MDS Degree Courses. A reservation for PWD category shall be implemented in each category on the total number of seats for that category in clinical, non-clinical subjects separately.

Note:- The regulations of Dental Council of India / National Dental Commission shall be implemented in admissions of candidates under Persons with Disability (PWD) category.

The candidate seeking admission under PWD reservation should apply under PWD Category. The Medical Board constituted by the University as per G. O. MS. No 27 HM&FW (C1) Dated 10-4-2017 will assess the percentage of disability as per Medical Council of India/DCI regulations. Candidates claiming reservation under PWD quota should present themselves before the Board constituted by University for evaluation of PWD percentage and confirmation of eligibility. The decision of Medical Board specially constituted for this purpose is final and binding on the candidates. The schedule of Medical Board evaluation will be displayed on KNRUHS website.

VI. SERVICE CANDIDATES' INCENTIVE OF ADDITION OF WEIGHTAGE OF MARKS

1. The regular service candidates who have put in 2 years or more of continuous service in tribal area / 3 years or more of continuous service in rural area of service are eligible for addition of weightage of marks.

2. The candidates should have qualified in the NEET-MDS-2026 Exam as per the cut-off marks prescribed for different categories to be eligible for addition of weightage of marks. Temporary / contract / Outsourcing candidates are not eligible for addition of weightage of marks.
3. **The addition of weightage of marks is as follows:**
 - a) **For Tribal service candidates: Eligibility:** 2-years of continuous regular service. Addition of weightage of marks as 10% per year on the marks secured by candidate in NEET MDS Exam up to maximum of 30%.
 - b) **For Rural service candidates: Eligibility:** 3-years of continuous regular service Addition of weightage of marks as 8% per year on the marks secured by candidate in NEET MDS Exam up to maximum of 24%.

VII.

ELIGIBILITY FOR DEPUTATION AND DEPUTATION PERIOD

Eligibility for Deputation & Deputation period will be decided as notified in G.O. Ms. No. 27 HM&FW (C1) Dept., Govt. of Telangana, Dated:10-04-2017 and subsequent amendments.

VIII.

ONLINE APPLICATIONS:

- a. ***The on-line application form for determining merit position in respective categories for Competent Authority Quota seats using NEET MDS – 2026 Rank will be available on the website <https://tsmds.tsche.in> from 06.00 AM on 19.08.2026 up to 06.00 PM on 25.08.2026.**

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application form from the website <http://knruhs.telangana.gov.in> and <https://tsmds.tsche.in> before proceeding to fill the application form.

***The tuition fee for the academic year 2026–27 shall be as per the Orders to be issued by the Government of Telangana.**

- IX.** The candidate should fill the online application form available in the Website with the data required through computer. The online application form can be filled through any computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the relevant Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the photo and signature after the payment of application fee through Online.

The candidate should have a valid mobile number to receive OTP and SMS regarding admissions.

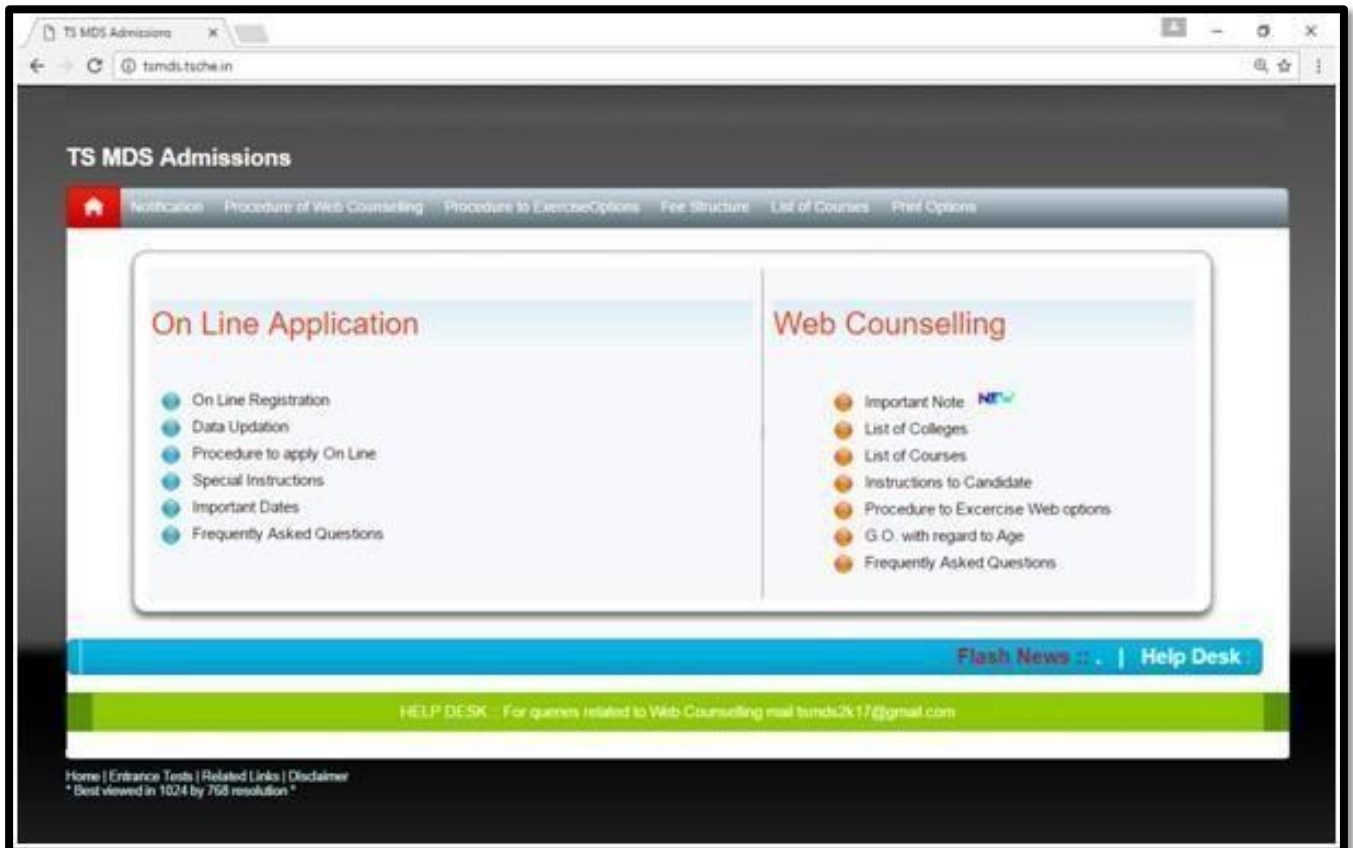

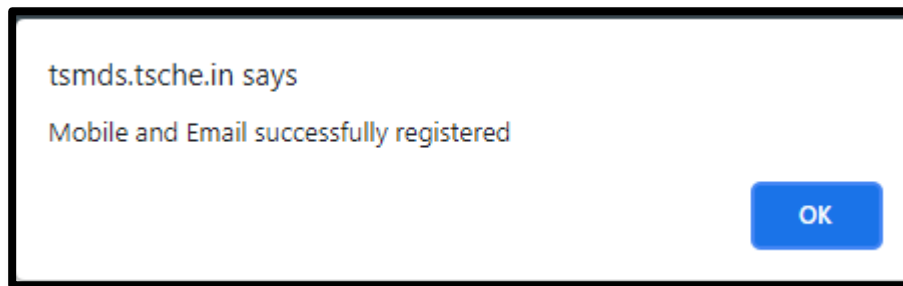

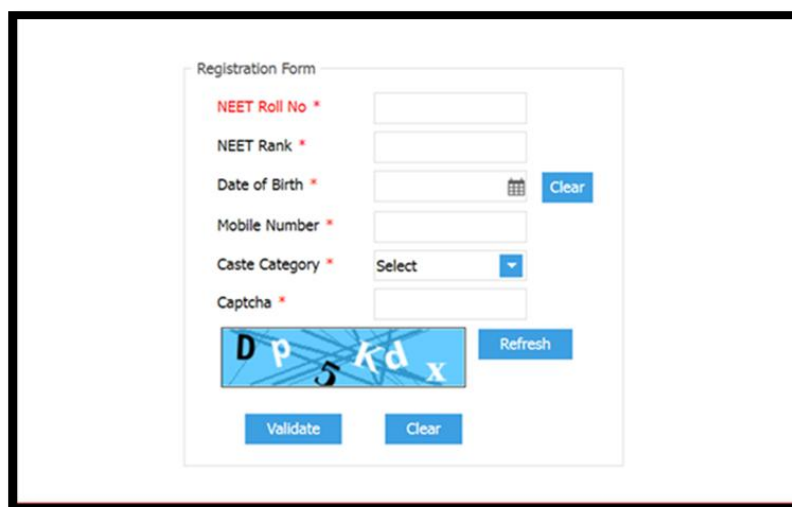

2. They should also answer all inquiries that may be sent to them by the Registrar in regard thereto, in order, that their correct addresses may be duly inserted in the Medical Register.
3. No charge is made for alteration of addresses. Once in five years the Registered Medical Practitioners must intimate his / her addresses to the Registrar for keeping the register alive.
4. A copy of the annual medical register where in the name appears will be supplied to every person registered on payment.
5. After the publication of name in the printed medical register the last edition of the register alone is the legal evidence of registration.
6. All persons registered under this act are eligible to practice modern system of Medicine.

5. Registration and Processing fee:

- a. The registration and processing fee is Rs.7,000/- (Bank transaction charges extra) for OC, BC categories and Rs.5,500/- (Bank transaction charges extra) for SC, ST categories.
- b. Registration and processing fee once paid shall not be refunded or adjusted to a future date under any circumstances.

Note: The candidature of the applicant will not be considered for admission to MDS courses unless the candidate uploads all relevant scanned original certificates.

6. MERIT LISTS:

The final merit position of the candidates who have applied online in response to the notification issued by KNR University of Health Sciences for Competent Authority Quota seats shall be determined by NEET- MDS- 2026 rank and as per their eligibility criteria, applicable regulations, guidelines and reservation policies viz:

- a) As per MDS Regulations of NDS/DCI, the candidates who secure minimum of 50 Percentile marks for General category, 40 Percentile marks for SC/ST/BC candidates and 45 Percentile of marks for Persons with Disability category candidates in NEET MDS-2026 as per the cutoff scores, are only eligible for admission or as per any revised cut-off scores as decided by Government of India.
- b) The University will release final merit list of eligible candidates for exercising web options after verification of uploaded certificates by the University and the concerned departmental officers.

NOTE: Candidates who have applied online in response to this office notification for determining merit position for Competent Authority Quota seats shall upload the certificates online along with the application. Candidates have to submit one set of print out of application form, original certificates and self-attested copies of certificates at allotted college at the time of admission for verification. In case of any discrepancy, allotment of admission is cancelled.

7. COUNSELING:

The notification for schedule for exercising web options will be issued separately on KNRUHS website. Verification of uploaded certificates will be done only once for web-based counseling irrespective of number of rounds of exercising web-based options and number of counselings. Hence, candidates who have applied on-line are advised to upload all original certificates at the time of online registrations without fail for scrutiny by concerned departmental official. No individual communications will be sent.

Candidates are informed to check the website regularly for notifications.

The Admission Committee shall have power to review the selection in case of any errors, misrepresentation or glaring injustice and cancel the selection/admission. In all matters relating to selection and admissions, the decision of the Admission Committee shall be final and binding on the Candidates and selections cannot be questioned after admissions are closed.

8. ADMISSION RULES:

- a) The letter of selection of admission for selected candidates has to be downloaded from the website after payment of University fee through payment gateway.
- b) **All the candidates including In-service candidates joining the MDS courses shall execute bond at the time of admission on a stamped paper of Rs. 100/- as prescribed in Annexure-II to the effect that he / she will complete the prescribed period of training or in default to pay Rs.5,00,000/- (Rupees Five Lakhs only) to the University and shall refund the amount received as stipend up to that date to the Government. Bond proforma is shown in Annexure – II.**

- c) **Bond for service after completion of degree:** Candidate shall submit a bond for serving the State of Telangana as per existing Government Regulations at the time of admission.
- d) **Anti-Drug Declaration:** Candidate shall submit Anti Drug declaration/undertaking signed by the candidate and parent/guardian. Declaration proforma is shown in Annexure - iv
- e) **The candidates who discontinue the course after issue of notification for final round of counseling or later will have to pay discontinuation fee of Rs.5,00,000/- (Rupees Five Lakhs only) They will be debarred from participating in counseling's for admission into MDS for a period of three (3) years under KNR UHS.**
- f) The original certificates submitted at the time of admission to the Principal of the allotted college shall not be returned to the candidates until they complete their course.
- g) **ATTENDANCE:** Candidates selected for the various courses should be whole time students. Service candidates will have to apply for leave to prosecute their studies and are required to produce the leave sanction order from the Competent Authority not later than three months after joining the course. The candidate is required to put in a minimum of 80% attendance during each academic year for being eligible to appear for the examination.
- In a year all 365 days will be considered as working days and students should get 80% attendance each academic year separately to get eligibility for appearing for University exams. The remaining days of absence (including maternity leave) will be considered for extension.
- h) **LEAVE:** Students will be permitted to avail 30 days leave for each year of study. No Post Graduate is allowed to go on leave for more than 10 days at a stretch. In-case the absence of the candidate availing Medical Leave / Maternity Leave / Any other Leave or unauthorized absence is beyond 30 days in a year of the study, the period of study of the candidate will be extended to the extent of such period. No other leave is permitted.

- i) **MATERNITY LEAVE:** Women students can avail maternity leave up to 180 days only once in their MDS course of study and the study period will be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear in the University examination till the completion of study period as per MCI/DCI Regulations (Duration of course).
9. **BREAK OF STUDY AND RE-ADMISSION:** If a student is absent continuously for a period of 91 days to one year and seeks permission to attend the course, his/ her application in prescribed format by paying requisite fee in favor of Registrar, KNR University of Health Sciences payable at Warangal shall be forwarded to the Registrar, KNR University of Health Sciences with the recommendation of the Principal. Candidates who discontinue for more than two years are not permitted for re- admission. Regulations for readmission after break of study along with application format and fee payable is available in the University website. The candidates are advised to refer the regulations before submitting the application and paying the fee. If they fulfilled the regulatory conditions, they may submit applications through the Principal of the College by paying the fee. Candidates who discontinue the course for more than two years are not eligible for re admission as per GO.Ms.No.76, HM&FW (C1) Department Dated: 04-07-2023.
10. **PRIVATE PRACTICE:** Post Graduate students are not allowed to do private practice or consultation and should not accept any part time employment in any State or central or Quasi Government or private organizations during the period of Post Graduate study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.
11. **COLLEGE REGULATIONS:** Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

12. The Tuition fee payable for the Competent Authority Quota seats will be as notified by the Government of Telangana.
13. **CLOSURE OF ADMISSIONS:**
- a) The admissions shall be closed as per the time schedule given by the NDC.
 - b) Any vacancy that arises after closure of admissions shall not be filled.
14. **PERIOD OF TRAINING:** The duration of MDS Course is 3 Years. A candidate admitted into MDS course shall pass the examination within 4 years from the date of completion of the course. If he/she fails to pass the examination within the period specified above, he/she shall not be permitted to appear for the examination there after and qualify for the award of MDS Degree.
15. **COMMENCEMENT OF THE COURSE:** The course shall commence as per the schedule notified by NDC/MCC. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.
16. **POWERS OF THE PRINCIPAL:** Notwithstanding anything contained in these regulations, the Principal may, at any time before completion of the Post Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks' time from the date of the receipt of the show cause notice to submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents attached thereto or in the Statements made either before the authority In-charge of admissions or the Principal or any other manner. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana.

17. POWERS OF THE KNR UNIVERSITY OF HEALTH SCIENCES:

KNR University of Health Sciences, may either suo moto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake / false/ forged.

18. DISCIPLINE:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media or anywhere which amounts to dereliction of duties. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ DCI/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

19. RAGGING:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.

NOTE: All the dates are tentative and the University reserves the right to change them without assigning any reason or advance notice.
